#### **Section I.B. Program Changes**

- 1. Addition of the use of Ad Hoc Consultants for the Semiannual Program Review Section III.D.1): The IACUC may, at its discretion, utilize qualified ad hoc consultants in place of IACUC members to perform program review. When ad hoc consultants are utilized, the IACUC remains responsible for the evaluation, determination of corrective action, and reporting of all findings.
- 2. Change in Use of Ad Hoc Consultants for Semiannual Facility Inspection Section III.D.2): Findings for semi-annual facility inspections performed by ad hoc consultants may be reviewed by the Chair of the IACUC in place of an IACUC subcommittee or full committee review. The Chair would establish a reasonable and specific plan and schedule for correcting each deficiency.
- 3. Change in Conduction of Full Committee Meetings Section III.D.6):
  - a. In absence of both the IACUC Chair and Vice-Chair, the Attending Veterinarian, or member of the Animal Welfare Office staff, may lead the meeting.
  - b. If the primary reviewer is unavailable to present a submission to the full committee, the animal use protocol is presented by another IACUC member, or AWO staff member, familiar with the submission.
- 4. Change in Annual Continuing Review for USDA Regulated Species Section III.D.9): As an alternative to completing an Annual Review form in the on-line submission system, the PI or designee may participate in a post-approval monitoring audit of the animal use protocol. The IACUC then reviews the resulting report in place of the Annual Review form.
- 5. **Change in Training Section III.G. Research Staff:** CITI "Post-Procedural Care of Mice and Rats in Research: Minimizing Pain and Distress" is required for work with mice and rats, rather than all rodents.
