Dear Dr. Applebaum,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your letter dated February 11, 2022 reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Fred Hutchinson Cancer Research Center. Your letter supplements the information in the prompt telephone preliminary report on December 16, 2021. According to the information provided, OLAW understands that on December 10, 2021, two cages of mice were found with incomplete post-operative monitoring cage card records, and the mice appeared to be nearing humane endpoints. On physical exam, the mice were lethargic and hunched and became increasingly unresponsive to stimuli over the course of the evaluation. Both mice were immediately euthanized. It was subsequently determined that the mice had received an unapproved surgical procedure on December 9, 2021. The surgery performed on these NSG mice was only approved for subcutaneous placement of the scaffold, not for a laparotomy. The associated protocols are not PHS-supported.

The Principal Investigator confirmed that the unapproved activity was immediately stopped. The Principal Investigator also reminded all study personnel of the post-operative monitoring and documentation requirements, and the specific researcher involved was counseled by a clinical veterinarian on post-operative monitoring and documentation. The researcher also met with a regulatory veterinarian to discuss the approved IACUC protocol, emphasizing that procedures on live animals must be performed exactly as they are described in the protocol.

The IACUC directed the following additional corrective actions:

- The researcher must repeat the Comparative Medicine hands-on training course "Rodent Anesthesia and Aseptic Surgery Technique." The purpose of the repeat training is to emphasize post-operative monitoring expectations, record-keeping, and how to use the standard postoperative cage cards.
- The Principal Investigator and the entire research team must meet with CM clinical and regulatory veterinarians to verify that all animal users have access to the electronic protocol system and to confirm the research team's familiarity with the approved procedures on the IACUC protocol.

Based on the information provided, OLAW is satisfied that appropriate actions have been taken by the Fred Hutchinson Cancer Research Center to investigate this incident, provide corrective measures, and prevent recurrence. OLAW concurs that the incident warranted reporting. Although this activity was not PHS funded, the application of the expectations of the PHS Policy across the animal care and use program reduces any potential appearance of a double standard. We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Morse:

This letter serves as follow-up to an initial verbal notification made by (b) (6) on December 16, 2021, regarding a reportable event.

The Fred Hutchinson Cancer Research Center (Fred Hutch) Institutional Animal Care and Use Committee (IACUC) initially reviewed the reportable event at the January 4, 2022 IACUC meeting. The report was submitted on December 15, 2021 and described an event involving two mice that had received an unapproved surgical procedure on December 9, 2021.

On December 10, 2021, Comparative Medicine (CM) staff discovered two cages of mice had incomplete post-operative monitoring cage card records, and the mice appeared to be nearing humane endpoints. On physical exam, the mice were lethargic and hunched and became increasingly unresponsive to stimuli over the course of the evaluation. Both mice were immediately euthanized.

A review of the IACUC protocol revealed that the laparotomy with scaffold insertion procedure that had been done on these NSG mice was not in the IACUC-approved protocol. The use of alginate scaffolds was approved on the IACUC protocol, but only for subcutaneous placement and not in GVHD model mice (GVHD model mice are approved for other projects on the protocol).

The Principal Investigator confirmed that the unapproved activity was immediately stopped. The Principal Investigator also reminded all study personnel of the post-operative monitoring and documentation requirements, and the specific researcher involved was counseled by a clinical veterinarian on post-operative monitoring and documentation. The researcher also met with a regulatory veterinarian to discuss the approved IACUC protocol, emphasizing that procedures on live animals must be performed exactly as they are described in the protocol.

At the January 4, 2022, convened IACUC meeting, the Committee reviewed the event and the corrective actions that had already been taken. The Committee directed the following additional corrective actions:

- The researcher must repeat the Comparative Medicine hands-on training course "Rodent
 Anesthesia and Aseptic Surgery Technique." The purpose of the repeat training is to emphasize
 post-operative monitoring expectations, record-keeping, and how to use the standard postoperative cage cards.
- The Principal Investigator and the entire research team must meet with CM clinical and regulatory veterinarians to verify that all animal users have access to the electronic protocol system and to confirm the research team's familiarity with the approved procedures on the IACUC protocol.

All corrective actions were completed prior to the 2/1/2022 IACUC meeting. These corrective actions, along with the Principal Investigator's response, were reviewed at the 2/1/2022 meeting and the IACUC determined no further action was required.
