Dear Dr. Puri,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 28, 2022 letter reporting noncompliance with the PHS Policy on the Humane Care and Use of Laboratory Animals at the University of Southern California. Your letter supplements the information provided in the initial telephone report on August 5, 2021. According to the information provided it is understood that in May 2021, the IACUC was made aware of multiple incidents of unapproved euthanasia of mice, in addition to multiple violations relating to biosafety. The committee suspended the PI for an indefinite period. All IACUC protocols used by this laboratory were suspended. The PI and all members of the laboratory were not allowed access to animal facilities and were not allowed to carry out work of any kind involving research with animals. These were PHS-supported studies. All animals from these protocols were transferred to a holding protocol and non-federal funds used for housing.

The corrective and preventive measures included:

- 1. removal of the Pl from all IACUC protocols and all oversight of animal research.
- 2. transfer of responsibility for all animal research to a colleague.
- 3. limitation of the number of students, staff or fellows that would be permitted to work with animals.
- 4. identification of a single individual in charge of animal research who in association with the new Pl would critically assess all activity at all stages of experimentation.
- 5. a revised, more stringent management plan.
- 6. making efforts to change the culture in the laboratory, including attending meetings and training with the Director of Research Integrity at the University of Southern California.
- 7. submission of monthly reports describing research conducted and oversight activities.

The PI associated with these protocols was changed in 2021 and no longer reflects the PI to whom the suspension was given. With the change of PI and the modifications outlined above, the IACUC voted to partially lift the suspension, allowing the new PI and limited laboratory members to restart research. The original PI remains suspended indefinitely.

As of the date of this letter there have been no further incidents reported, the laboratory continues to attend training session with Director of Research Integrity, and the new PI remains in close contact with the IACUC.

OLAW appreciates the consideration of this matter by the University of Southern California, which was consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate this incident, correct the non-compliance, and prevent recurrence. OLAW concurs that the incident warranted reporting. We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Morse:

This is to report a suspension of animal use activity at the University of Southern California (animal welfare assurance number D16-00320/A3518-01). A preliminary report was provided to you on August 5, 2021. The IACUC protocols for this work were associated with PHS funding (R01DE021445, R01CA221521, R01CA134241 and R01DE026003). Please note that the PI associated with these protocols was changed in 2021 and no longer reflects the PI to whom the suspension was given.

In May 2021, the IACUC was made aware of multiple incidents of unapproved euthanasia of mice, in addition to multiple violations relating to biosafety. This was the third serious violation by the same laboratory within the prior two years. Given that the two prior incidents also resulted in a period of suspension, the committee on this occasion suspended the PI for an indefinite period. All IACUC protocols used by this laboratory were suspended. The PI and all members of the laboratory were not allowed access to animal facilities and were not allowed to carry out work of any kind involving research with animals. All animals from these protocols were transferred to a holding protocol and non-federal funds used for housing.

In response to this suspension the PI, his colleagues and the IACUC engaged in over 3 months of discussions and meetings in an effort to foster fully compliant research activities in this laboratory.

In summary the PI apologized for the incident, explained how the issues came about, provided detailed steps he and his colleagues were taking to ensure no further issues occurred, and agreed to increased monitoring and training. This included:

- removal of the PI from all IACUC protocols and all oversight of animal research.
- 2. transfer of responsibility for all animal research to a colleague.
- limitation of the number of students, staff or fellows that would be permitted to work with animals.
- 4. identification of a single individual in charge of animal research who in association with the new PI would critically assess all activity at all stages of experimentation.
- a revised, more stringent management plan.
- 6. making efforts to change the culture in the laboratory, including attending meetings and training with the Director of Research Integrity at the University of Southern California.
- 7. submission of monthly reports describing research conducted and oversight activities.

With the change of PI and the modifications outlined above, the IACUC voted to partially lift the suspension, allowing the new PI and limited laboratory members to restart research. The original PI remains suspended indefinitely.

As of the date of this letter there have been no further incidents reported, the laboratory continues to attend training session with Director of Research Integrity, and the new PI remains in close contact with the IACUC.
