Dear Dr. Mataric,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your July 14, 2021 letter reporting noncompliance with the PHS Policy on the Humane Care and Use of Laboratory Animals at the University of Southern California. Your letter supplements the information provided in the initial telephone report on May 10, 2021. According to the information provided it is understood that on March 18, 2021, two rats were found lethargic and exhibiting signs of severe pain. The post-operative cards on the cages were incomplete, missing pertinent information including analgesic administration. The rats were immediately administered both Buprenorphine SR and Meloxicam by the veterinarian. One rat died and the other survived to the experimental endpoint. Two other rats had also undergone the same surgery but did not show signs of pain. These rats also survived to endpoint and were given pain meds by the veterinarian. The related protocols were supported by PHS funds but billing for the care of these rats was transferred to non-federal funding sources.

Corrective and preventive actions: The IACUC discussed these incidences at a convened meeting with a quorum and voted to suspend this lab from work with laboratory animals on all protocols for 90 days. The following corrective actions were required by the IACUC at the time of suspension:

- 1. The Principal Investigator (Pl) was required to provide a written explanation to the IACUC why the research staff thought it was appropriate and humane to perform painful major survival surgery on animals and not administer appropriate pain medication.
- 2. The PI and laboratory staff working with animals were required to complete training in anesthesia, analgesia, surgical skills, and compliance, including one extra AALAS training course on pain management.
- 3. The PI was required to provide the IACUC with all surgical records for survival and nonsurvival surgeries conducted in the last two years.
- 4. The PI was required to amend the protocol to clarify experimental endpoints and adverse events.

The PI provided a complete response to all of the required items. The response from the PI, including training documentation for the PI and lab members, was reviewed at the full IACUC meeting. The response was deemed acceptable by the committee who voted to lift the suspension early. To date there have been no other instances of noncompliance in this principal investigator's laboratory.

OLAW appreciates the consideration of this matter by the University of Southern California, which was consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate this incident, correct the non-compliance, and prevent recurrence. OLAW concurs that the incident warranted reporting. We appreciate being informed of this matter and find no cause for further action by this office.

This is to report a suspension of animal use activity at the University of Southern California (animal welfare assurance number D16-00320/A3518-01). A preliminary report was provided to you on May 10th, 2021. The IACUC protocols for this work were associated with PHS funding (# 5R01EY017918-14).

On March 18, 2021, 2 rats were found lethargic and exhibiting signs of severe pain. The postoperative cards on the cages were incomplete, missing pertinent information including analgesic administration. The rats were immediately administered both Buprenorphine SR and Meloxicam by the veterinarian. One rat died and the other survived to the experimental endpoint. 2 other rats had also undergone the same surgery but did not show signs of pain. These rats also survived to endpoint and were given pain meds by the veterinarian.

Billing for the care of these rats was transferred to non-federal funding sources.

The IACUC discussed these incidences at a convened meeting with a quorum on April 21, 2021 and voted to suspend this lab from work with laboratory animals on all protocols for 90 days. The following corrective actions were required by the IACUC at the time of suspension:

- 1. The Principal Investigator (PI) was required to provide a written explanation to the IACUC why the research staff thought it was appropriate and humane to perform painful major survival surgery on animals and not administer appropriate pain medication.
- 2. The PI and laboratory staff working with animals were required to complete training in anesthesia, analgesia, surgical skills, and compliance, including one extra AALAS training course on pain management.
- 3. The PI was required to provide the IACUC with all surgical records for survival and nonsurvival surgeries conducted in the last 2 years.

4. The PI was required to amend the protocol to clarify experimental endpoints and adverse events.

The PI provided a complete response to all of the required items by June 9,2021. In the response the PI acknowledged and apologized for the oversight of the laboratory but pointed out that the animals had in fact received some analgesic pre-operatively, though this was inadequate.

The totality of the response from the PI, including training documentation for the PI and lab members was reviewed at the full IACUC meeting on June 16, 2021. The response was deemed acceptable by the committee who voted to lift the suspension early. To date there have been no other instances of noncompliance in this principal investigator's laboratory.
