The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your May 13, 2022 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Rutgers, The State University of New Jersey following up on an initial May 5, 2022 notification by telephone.

According to the information provided, this Office understands that the Rutgers Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: conditions that jeopardized the health and well-being of animals resulting in death and harm to animals. The final report states on February 1, 2022, an overcrowded cage of mice was flagged for euthanasia. The cage was later discovered with several moribund mice and several deceased mice. In response, the remaining animals were immediately euthanized.

Investigative results determined a laboratory member combined 12 mice into a single cage and intended to perform euthanasia. However, the individual did not perform euthanasia in a timely manner and the animals were left in the cage overnight. Per the report, the IACUC discussed the matter and determined it was reportable to OLAW on February 8, 2022 and accepted the following corrective actions:

- The Principal Investigator (PI) was counseled by the IACUC Chair and Comparative Medicine Resources (CMR) veterinary staff.
- A retraining session for all lab members, including the PI, was performed by a CMR veterinarian and an IACUC Office Post-Approval Monitor.
- An IACUC Office Post-Approval Monitor performed additional follow up with the laboratory to ensure continued compliance.
- The IACUC Policy "Overcrowding and Single Housing for Rodents" was revised to further clarify the requirements for laboratories to comply with mandatory cage density requirements.

It is noted that this research is supported by PHS funding. Based on its assessment of this explanation, OLAW understands that the Rutgers, The State University of New Jersey has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy. We appreciate being informed of these matters and find no cause for further action by this Office.



Rutgers, The State University of New Jersey hereby makes the final report for the following incident, reported to OLAW via telephone on May 5, 2022. On February 1, 2022, an overcrowded mouse cage flagged for euthanasia was observed with several deceased and several moribund animals.

The following actions were taken in response to this incident:

- The remaining animals were immediately euthanized.
- Investigation indicated that a laboratory member combined 12 mice into a single cage with the
 intention of euthanizing the animals but then did not do so in a timely manner and the animals were
 left in the cage overnight.
- The PI was counseled by the IACUC Chair and Comparative Medicine Resources (CMR) veterinary staff
- A re-training session for all laboratory members, including the PI, was performed by a CMR veterinarian and an IACUC Office Post Approval Monitor.
- An IACUC Office Post Approval Monitor performed additional follow up with the laboratory to ensure continued compliance.
- The IACUC Policy "Overcrowding and Single Housing for Rodents" was revised to further clarify the requirements for laboratories to comply with mandatory cage density requirements.
- At its regular meeting on February 8, 2022, the IACUC reviewed and discussed these incidents and unanimously voted to report this matter to OLAW. The IACUC also voted to accept the above noted corrective actions.

Please note that these animals were supported by NIH funds.


