Dear Dr. Polonsky,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your May 23, 2022 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals within the animal care and use program at the University of Chicago. Your letter supplemented the information contained in an initial email report to this office on April 19, 2022. According to the information provided, OLAW understands that a cecal ligation and puncture surgery not approved by the IACUC was performed on mice. Upon notification, the responsible individual euthanized the animals and halted further experiments. An amendment to include the procedure was under review by the IACUC and the responsible laboratory member mistakenly believed that the procedure had been approved. The mice involved in this incident were supported by PHS funds.

The IACUC approved several corrective and preventive measures in response to this incident. The Principal Investigator (PI) and laboratory staff will undergo retraining regarding the importance of compliance and the consequences of noncompliance. The PI will develop a comprehensive plan to ensure that staff are aware of and compliant with approved protocol(s) and IACUC policies and guidelines. The laboratory manager will review cage cards weekly to verify that the correct protocol is assigned. Further, amendments will be reviewed at laboratory meetings to confirm approved procedures. When approved, a veterinarian will observe the cecal ligation and puncture procedure and the PI will submit a report to the IACUC on a pilot study to refine the procedure and develop appropriate endpoints to mitigate morbidity and mortality.

OLAW appreciates the consideration of this matter by the University of Chicago, which was consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate this incident and prevent recurrence. However, in future reports, please include the approximate number of animals affected.

We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Morse,

I write to provide the final report of an incident the University of Chicago IACUC determined represented a serious deviation from the provisions of the *Guide for the Care and Use of Laboratory Animals*.

(b) (6) provided a preliminary report by email on April 19, 2022.

The incident involved performing a surgical procedure (cecal ligation puncture) not approved by the Committee that resulted in morbidity and mortality. Upon being notified, the individual conducting the experiment promptly euthanized the animals and halted further experiments. An account of the events that occurred was provided by the Principal Investigator.

The amendment to include the cecal ligation puncture surgery was currently under review by Committee and the individual responsible mistakenly believe the procedure to have been approved. After discussing, the IACUC was concerned laboratory staff were not aware of procedures approved in laboratory protocols. To ensure the laboratory had an appreciation for the importance of compliance and the consequences of non-compliance, the IACUC requested the principal investigator and staff successfully complete the "Working with the IACUC" and the "Common Compliance Issues" training courses available at the AALAS Learning Library. The Committee also requested the investigator develop a comprehensive plan to ensure staff were aware of and document compliance with approved protocol(s) and IACUC policies and guidelines.

To ensure continued training and compliance with approved protocols, laboratory staff have been provided all approved protocols to review and are to ensure animals are assigned to the appropriate protocol for experimental procedures. The laboratory manager will review cage cards weekly to verify the correct protocol is assigned. As amendments are approved, they will be reviewed at laboratory meetings to confirm approved procedures.

In addition, the IACUC has requested a veterinarian observe the surgical procedure and the Principal Investigator to report on a pilot study to refine the procedure and develop appropriate endpoints to mitigate morbidity and mortality. With this framework in place, the IACUC was satisfied with the response and considers this matter resolved. NIH Grant 2P01AI097113 and internal funding supported the protocol under which the animals were assigned.

We trust that the corrective measures taken for this non-compliance incident by the IACUC are appropriate.
