- Cage wash update
  - o 676 cage washes
  - 0 deficiencies
- USDA meetings
  - USDA/APHIS/IES conducted 19 interviews among staff on both campuses
- INA update

- INA is a group that monitors activity on anti-animal research organization websites and submits summaries to the research community
- Update from ILT
  - A researcher brought a concern to the IACUC regarding what they had heard from a research technician. The concern was for appropriate training by a CVT who conducted a procedure on an infant. The investigation found there was a miscommunication between the research and CVT staff members. The CVT was appropriately trained and competent in conducting the procedure and anesthesia and analgesia were administered appropriately. The animal recovered without incident and no incidence of non-compliance was found.
