The IACUC discussed whether it was necessary to continue reviewing updates to operational SOPs. Members expressed satisfaction and confidence in ARRS's training competency and review process. They agreed that recent administrative changes separating the Attending Veterinarian from overseeing facility operations prevents a potential conflict of interest and enhances oversight. ARRS will no longer be required to submit SOPs for operational aspects of equipment sanitation for IACUC review and approval.

Motion: A motion was made and seconded to delegate review and approval of facility operational SOPs to ARRS. The IACUC voted and approved the motion. (12-In favor, 0-Opposed, 0-Abstained)
