Dear Dr. Lakin,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your December 9, 2021 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Colorado - Denver. This letter had not been preceded by a preliminary report to OLAW.

According to the information provided, this Office understands that the University of Colorado - Denver Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: the deaths of animals due to failure to perform euthanasia. The final report states an investigator self-reported when performing several cage separations. One cage housing only mouse pups was returned to the rack instead of being euthanized. As a result, 11 mouse pups died.

In response to the incident, the investigator counseled the lab members, and the lab will alter their process in the future to only handle one cage at a time to avoid future recurrence. At a convened meeting of a quorum of the IACUC, the committee accepted the actions taken.

It is noted the investigator is supported by NIH funding. Based on its assessment of this explanation, OLAW understands that the University of Colorado - Denver has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

Dear Dr. Morse;

The Institutional Animal Care and Use Committee (IACUC) at the University of Colorado Denver | Anschutz Medical Campus received a report of an animal welfare incident; specifically, the PI self-reported when performing several cage separations, one cage containing only mouse pups was returned to the rack instead of being euthanized. This resulted in the death of eleven mouse pups.

The Primary Investigator counselled the lab members and the lab will alter their process in the future to only deal with one cage at a time to avoiding the confusion that led to this error.

At a convened meeting of a quorum of the IACUC, a majority of the quorum present determined to accept the actions as taken. The Committee determined further that the Office of Laboratory Animal Welfare (OLAW) be informed of this incident. (NIH Grant # AI066121)
