Dear Dr. Russell,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your June 8, 2021 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals within the animal care and use program at the University of Texas – Southwestern Medical Center. Your letter supplements the information in the preliminary telephone report to our office on March 25, 2021. According to the information supplied, OLAW understands that on March 12, 2021 a research staff member administered an IACUC-approved special diet to six cages of mice using an unapproved feeding method. The staff member also did not monitor these animals at the frequency described in the approved protocol, and one dead mouse was found on March 10, 2021 and another on March 11, 2021. This incident involved animals that were supported by funding from the PHS.

Corrective and preventive actions included the research staff member being counseled by an IACUC liaison and the laboratory manager confirming that animals would be monitored per the approved protocol. An amendment would also be submitted to update the method of diet administration, but On March 30, 2021, it was observed that eight cages of mice were being administered the special diet using the unapproved method although the amendment had not yet been submitted. The PI was counseled and voluntarily terminated the experiment. The amendment was submitted and was subsequently approved.

The prompt consideration of this matter by the University of Texas – Southwestern Medical Center was consistent with the philosophy of institutional self-regulation and self-correction. Although it is troubling that the unapproved feeding method continued to be used, OLAW recognizes that your program dealt with the issue accordingly. We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Morse,

I write to provide a final report of non-compliance with the *PHS Policy on Humane Care and Use of Laboratory Animals* regarding an incident on March 12, 2021. The IACUC determined that a research staff member administered a special diet described within the IACUC-approved protocol to six cages of mice using an unapproved feeding method. The IACUC determined that this staff member also did not monitor these animals at the frequency described in the approved protocol, and animal facility veterinary staff found one dead mouse on March 10, 2021 and another on March 11, 2021. These determinations were based on observations made by a Sr. IACUC Liaison. This incident was first reported to you via voicemail message by an IACUC Manager on March 25, 2021.

The responsible staff member was counseled by a Sr. IACUC Liaison on March 12, 2021. On March 22, 2021, the laboratory manager confirmed that animals would be monitored per the approved protocol and an amendment would be submitted to update the method of diet administration.

On March 30, 2021, a Sr. IACUC Liaison observed eight cages of mice being administered the approved special diet using the unapproved method, since the amendment to update the method of diet administration had not yet been submitted. The PI was counseled by an IACUC Manager on April 1, 2021 and voluntarily terminated the experiment immediately. An amendment was submitted on April 12, 2021 to update the description of the diet administration and this amendment was approved by the IACUC on May 19, 2021.

We believe the actions taken by the IACUC are appropriate for this situation.
