Dear Dr. Halvorsen,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 7, 2022 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University at Buffalo, State University of New York. This letter had not been preceded by a preliminary report to OLAW.

According to the information provided, this Office understands that the University at Buffalo, State University of New York Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: failure to perform aseptic technique. The final report states a laboratory was identified not using aseptic technique during a cannulation procedure. The incident was reported by a Department of Health Inspector. The individuals were noted performing surgery using nonsterile gloves. Also, the surgical field and surgical instruments were compromised, and non-sterile items were located within the surgical field. It is understood 32 mice underwent the procedure, and no complications were observed in the animals due to lack of aseptic technique.

On December 20, 2021, the IACUC reviewed the Principal Investigator's letter describing how they will provide laboratory personnel with appropriate oversight and ensure aseptic technique is adhered to. The individuals associated with the event completed their retraining requirements. It is understood the committee accepted the retraining of personnel and the investigator's corrective action plan.

It is noted the study is supported by NIH funding. Based on its assessment of this explanation, OLAW understands that the University at Buffalo, State University of New York has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

The incident was reported by a Department of Health (DOH) Inspector. During the DOH inspection, two individuals were observed performing surgery using non-sterile gloves, and the sterile field was compromised, including some surgical instruments. A cellphone and laptop were also located within the sterile field. The individuals worked on a total of 32 mice. Neither the veterinary staff nor PI reported any complications due to the lack of aseptic technique. This study is supported by NIH funding.

On December 20, 2021, the committee reviewed the PI's letter outlining how they will provide laboratory personnel with appropriate oversight and ensure aseptic technique is followed. The staff members in question completed their retraining requirements. The IACUC committee has accepted the personnel retraining and the PI's corrective action plan to prevent future instances of non-compliance.

The incident was reported by a Department of Health (DOH) Inspector. During the DOH inspection, two individuals were observed performing surgery using not sterile gloves, and the sterile field was compromised, including the surgical instruments. A cellphone and laptop were also located in the sterile field. The individuals worked on a total of 32 mice. Neither the Veterinary staff nor PI reported any complications with these animals due to this incident. This study is supported by NIH funding.

On November 29, 2021, the committee reviewed the DOH report and noncompliance incident during a fully convened meeting with a quorum of members. The committee determined that the following steps must be completed:

- 1. The PI must submit a letter stating how they will provide laboratory staff with appropriate oversight and ensure aseptic technique is followed for all surgical procedures as outlined in the protocol and according to LAF SOP 2.A.3 (*Rodent Surgery*).
- 2. The staff members in question need to retake *Introduction to Surgery*, both the UBlearns on-line and the in-person components of the course, within 30 days of receiving this letter.
