Dear Dr. Halvorsen,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 7, 2022 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University at Buffalo, State University of New York. This letter had not been preceded by a preliminary report to OLAW.

According to the information provided, this Office understands that the University at Buffalo, State University of New York Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: failure to use aseptic technique during a surgical procedure. The final report states an individual was identified not using aseptic technique when performing an IACUC-approved surgical procedure. The Department of Health Inspector observed the incident and noted the individual's cell phone was within the sterile field and touched while wearing sterile gloves. The surgery was performed on a total of 3 rats. Per the report, the veterinary staff nor the Principal Investigator (PI) reported any complications due to the lack of aseptic technique.

The IACUC reviewed the PI's letter describing how laboratory personnel will be provided with appropriate oversight and ensured aseptic technique will be followed. The individual responsible for the incident has completed their retraining requirements. The committee accepted the retraining of personnel and the corrective action plan. It is noted that this study is supported by NIH funding.

Based on its assessment of this explanation, OLAW understands that the University at Buffalo, State University of New York has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

The University at Buffalo, the State University of New York, in accordance with A3354-01 and PHS Policy IV.F.3, is providing a final report of non-compliance that occurred under PROTO202100165 in which an individual from the lab was observed not using aseptic technique during a surgical procedure as described in the protocol. The incident was reported by a Department of Health (DOH) Inspector. During the DOH inspection, the individual's cell phone was within the sterile field, and they touched the phone several times while wearing sterile gloves. The individual had performed surgery on a total of three rats. The Veterinary staff nor PI reported any complications due to the lack of aseptic technique. This study is supported by NIH funding.

On December 20, 2021, the committee reviewed the PI's letter outlining how they will provide laboratory personnel with appropriate oversight and ensure aseptic technique is followed. The staff member in question completed their retraining requirements. The IACUC committee has accepted the personnel retraining and the PI's corrective action plan to prevent future instances of non-compliance.

The University at Buffalo, the State University of New York, in accordance with A3354-01 and PHS Policy IV.F.3, is providing an initial non-compliance report that occurred under PROTO202100165 in which an individual from the lab was observed not using aseptic technique during a surgical procedure as described in their approved protocol. The incident was reported by a Department of Health (DOH) Inspector. During the DOH inspection, the individual's cell phone was within the sterile field, and they touched the phone several times while wearing sterile gloves. The individual had performed surgery on a total of three rats. Neither the Veterinary staff nor the PI reported any complications with these animals due to this incident. This study is supported by NIH funding.

On November 29, 2021, the committee reviewed the DOH report and non-compliance incident during a fully convened meeting with a quorum of members. The committee determined that the following steps must be completed:

- 1. The PI must submit a letter stating how they will provide laboratory staff with appropriate oversight and ensure aseptic technique is followed during surgical procedures as outlined in the protocol and according to LAF SOP 2.A.3 (*Rodent Surgery*).
- 1. The staff members in question need to retake the institution's course, *Introduction to Surgery*, both the UBlearns on-line and the in-person components of the course, within 30 days of receiving this letter.
