Dear Dr. Lakin,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your December 9, 2021 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Colorado - Denver. This letter had not been preceded by a preliminary report to OLAW.

According to the information provided, this Office understands that the University of Colorado - Denver Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: use of an unapproved method of euthanasia involving a mouse. The final report states a research assistant used a mouse euthanasia method that was not approved on the protocol. In response, the research assistant was counseled and retrained by the primary investigator. The individual expressed remorse and reread the IACUC-approved protocol. Also, the investigator developed a remediation plan limiting the number of projects the individual is assigned to. Per the report, this limits the number of protocols the individual must keep track of and avoids complex and over scheduled days. The IACUC accepted the corrective actions regarding the matter.

It is noted that this research is supported by PHS funding. Based on its assessment of this explanation, OLAW understands that the University of Colorado - Denver has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

Dear Dr. Morse;

The Institutional Animal Care and Use Committee (IACUC) at the University of Colorado Denver | Anschutz Medical Campus received a report of an animal incident. Specifically, a research assistant was using a mouse euthanasia method that was not in the IACUC approved protocol. The euthanasia method had been approved in their previous IACUC protocols.

The research assistant was counselled and retrained by the Primary Investigator. The research assistant has expressed remorse and has carefully reread the IACUC approved protocol in detail. Additionally, the Primary Investigator developed a remediation plan limiting the number of projects that the research assistant is on. This limits the number of IACUC protocols the research assistant needs to keep track of and prevents complex and over scheduled days.

At a convened meeting of a quorum of the IACUC, a majority of the quorum present determined that this was a protocol deviation and accepted the corrective actions described above. The Committee determined further that the Office of Laboratory Animal Welfare (OLAW) be informed of this incident (NIH Grant # AR070879).
