I. Program Changes

Change(s) in this institution's program for animal care and use as described in the Assurance have occurred during this reporting period.

On January 1, 2021, (b) (6) Ph.D., Research Microbiologist, replaced (b) (6) (b) (6) as the Chairperson for the CFSAN. Additionally, (b) (6), Ph.D. was appointed Institutional Official, replacing (b) (6) DVM, Ph.D., DACVPM. The CFSAN Animal Care and Use program and research facility is now located at the Gulf Coast Seafood Laboratory (GCSL) (Dauphin Island, AL).

The animal facility at (b) (6) is no longer being used to conduct live animal research and therefore all research under the CFSAN Animal Care and Use program and IACUC will be performed at the (b) (6). To reflect these changes, a new committee was formed on August 3, 2021. Major changes to the animal research program include a focus of research on aquatic animals and a discontinuation of radioactive materials in research. A semi-annual program review was performed as soon as this newly formed committee met on October 6, 2021.

A facility inspection waiver was granted to the CFSAN Animal Care and Use program on February 11, 2021 and until access to facility has been restored. Semi-annual facilities inspection for (b) (6) will be conducted once personnel are able to safely return to the laboratory
