The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of the April 29, 2021 letter submitted by the US Army Research Institute of Infectious Diseases, Institutional Animal Care and Use Committee chair reporting a serious deviation from the provisions of the *Guide for the Care and Use of* Laboratory *Animals*, following up on an initial report on March 10, 2021. According to the information provided, OLAW understands that a male and female nonhuman primate were found mating in a social housing cage after escaping their primary enclosure due to a latch being open.

The corrective actions consisted of separating the monkeys, which were not injured, and providing emergency contraceptive for the female. The animal caretakers have been retrained on ensuring that cages are secured.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to reduce the likelihood of a recurrence. OLAW concurs with the actions taken by the IACUC to comply with the PHS Policy on Humane Care and Use of Laboratory Animals. In future, please have all final noncompliance reports submitted to OLAW under your signature. Thank you for keeping OLAW apprised on this matter.

The pregnancy is only a partial concern (i.e., may affect a study), however, the unintended ability to open a separation grid could lead to serious injury or death. So the issue is the integrity of the cages and if animals can get out, it constitutes a serious deviation from the *Guide*. See what your IACUC and vets say as to whether they see a problem with either caging, SOPs, or staff training.




On 19Feb21, two NHPs of different sexes were found in the same play cage. One of the NHPs was able to open the separation grid and were found mating at around 1100 hrs. Once found they were immediately separated. No animals were injured during this paired social event.

Due to the unintentional mating, the Female NHP has been put on an emergency contraceptive. Because this contraceptive is not a 100% effective we will be assessing this NHP with an ultrasound in 30 days.

Once again, I wanted to cover my bases. I wouldn't consider this an AWI, unless an infant NHP resulted (ie confirmed pregnant). I think unintentional mating is always a risk when housing NHPs. With that being said, I prefer to notify OLAW just to make sure. Your thoughts?
