### Regulatory Authority:

As per University of Arizona Policy 2.13.03 Research Involving Animal Subjects, "All research, both sponsored and non-sponsored, involving animal subjects must be reviewed by the Institutional Animal Care and Use Committee (IACUC) to ensure that it conforms to University policies governing animal welfare and meets the requirements of the federal Animal Welfare Act and the Public Health Service Policy on Humane Care and Use of Laboratory Animals."

As per the USDA Animal Welfare Act (AWA) 2143.b.1.B.iii, the IACUC shall include a community member in order to "provide representation for general community interests in the proper care and treatment of animals;..."

Further, AWA section 2.33 requires the Attending Veterinarian (AV) and/or their designees "has the appropriate authority to ensure the provision of adequate veterinary care and oversee the adequacy of other aspects of animal care and use..." and "The use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries," and that daily health and well-being is assessed and conveyed to the AV and/or their designees.

As per IACUC Guidance 113:

"The IACUC expects that for all animal activities at the University of Arizona, animal welfare is a primary focus."

### Description of welfare report

On 9/20/21 the IACUC was made aware of a report sent to the Vice President of Agriculture – Life and Veterinary Sciences, by a concerned student, regarding the condition of the College of Veterinary Medicine's horse herd at the The report indicated, "I believe they have had these set of horses for about a year. As far as I know their condition has not changed. Even if these horses are sick it is not humane to keep these horses in this condition. If they are sick, find out what is wrong with them and treat them accordingly. Especially out in this Arizona heat, these horses are starving, their BCS is around a 1 or 2 which is not proper care of these animals. Something needs to be done about these animals immediately, especially since they are thousands of people drive by the farm daily and it is a bad look for the university."
