The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 25, 2023 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Columbia University. Your letter supplements the information in the initial prompt telephone report on October 19, 2022. According to the information provided, OLAW understands that on October 17, 2022, your institution was notified that an unapproved non-survival surgery had been performed on three mice. Although the research was PHS funded, no funds were used for the conduct of the unapproved activity.

The principal investigator took full responsibility and stated that it was an oversight, and he described measures he had put in place to prevent any recurrence, which included posting in multiple locations, a list of presently approved laboratory protocols and their expiration dates. Additionally, during weekly laboratory meetings, he and his staff will review the list of the group's approved protocols and their expiration dates.

OLAW appreciates the consideration of this matter by Columbia University, which was consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate this incident, correct the noncompliance, and prevent recurrence. OLAW concurs that the incident warranted reporting. We appreciate being informed of this matter and find no cause for further action by this office.

On October 19, 2022, Columbia University (the "University") notified the Office of Laboratory Animal Welfare ("OLAW") by telephone of a reportable situation involving conduct of a non-survival surgical procedure in three mice without Institutional Animal Care and Use Committee ("IACUC") approval. The animals involved were being used in research supported by the Public Health Service under NIH grant numbers 5R01HL144852-03 and 5R35GM140880-02.

This letter reports the results of a review of the matter and the corrective actions taken by the IACUC.

Background and Investigation

On October 17, 2022, an IACUC compliance monitor notified Dr. Mary Jo Shepherd, Executive Director of the Office of the IACUC, that an unapproved non-survival surgery had been performed on three mice.

Dr. Shepherd notified the IACUC Chair when she learned of the findings and an investigation was initiated. The IACUC investigative team (Dr. Shepherd and another IACUC member) met separately with the responsible principal investigator and the IACUC compliance monitor who brought the incident to Dr. Shepherd's attention. The principal investigator took full responsibility and stated that it was an oversight, and he described measures he had put in place to prevent any recurrence. The compliance monitor noted that the principal investigator's group had a good compliance history.

Corrective Actions

A report from the investigative team was provided to the IACUC at a convened meeting of the Committee, at which a quorum was present, on December 8, 2022. Following review of the facts and discussion, the Committee imposed the following corrective measures:

- 1. The investigator was required to fully implement and continue to adhere to his plan for correction, which included posting in multiple locations, a list of presently approved laboratory protocols and their expiration dates.
- 2. Additionally, during weekly laboratory meetings, he and his staff will review the list of the group's approved protocols and their expiration dates.

Note that no federal funds were used for the conduct of this unapproved activity.
