Dear Mr. McIntire,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 13, 2023 letter concerning a report of a noncompliance with the Public Health Service Policy on the Humane Care and Use of Laboratory Animals within the animal care and use program at SRI International. Your letter supplements the information contained in a preliminary phone report submitted on December 29, 2022. According to the information provided, OLAW understands that nine male mice on an irradiation study were not properly removed from study after meeting the IACUC protocol's euthanasia criteria. The activity was PHS funded.

Corrective and preventive measures: the research staff received refresher training that included review of the protocol's early removal criteria for irradiation studies. The funding agency was notified separately.

SRI International's reporting of the matter was consistent with the philosophy of self-regulation. Similarly, the action taken to respond to the issue was appropriate. We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Morse:

This letter is the written report of the incident phoned in by SRI's IACUC Chair on December 29, 2022.

The protocol noncompliance incident involved 9 mice on an irradiation study being conducted for the National Institute of Allergy and Infectious Diseases (NIAID), contract# 75N93020D00011 (TO B-2, 75N93021F00002).

Nine irradiated male animals were not properly removed from study after meeting the IACUC protocol's euthanasia criteria on either Days 5 or 6 post irradiation. Although they had met removal criteria, none of these animals were found dead. Missed removals were discovered during data review following the end of the in-life phase of the study.

Four of the animals met removal criteria on Days 5 or 6, but instead were removed one day late on either Days 6 or 7, respectively. Removal criteria that qualified their euthanasia were moderate body weight (20-29% weight loss) and either moderate hunched posture or ruffled fur, and minimally one additional slight clinical finding (ruffled fur, dehydration, and/or hunched posture). The remaining five animals also met removal criteria (1/Day 5 and 4/Day 6), but were mistakenly not removed from the study. These animals remained on study and survived to the end of the study on Day 29.

To prevent such noncompliance from recurring, the research staff received refresher training that included review of the protocol's early removal criteria for irradiation studies.

The funding agency was notified separately.

SRI fully understands all the implications of deviations from IACUC protocols and will take all reasonable approaches to prevent a recurrence. Please do not hesitate to contact me should you have any questions.
