Dear Dr. Dickinson,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 11, 2023 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Baylor College of Medicine. According to the information provided, OLAW understands that five mice were given expired ketamine as part of a euthanasia cocktail. No adverse events occurred due to use of the expired agent.

The corrective actions consisted of retraining the laboratory staff and having the staff review relevant institutional policies.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

Dear Dr. Morse,

As Institutional Official for Baylor College of Medicine (BCM), I have the duty to inform you of our Institutional Animal Care and Use Committee's (IACUC) recent findings in animal research after an assessment of the following protocol:

Protocol: AN-7988: Light Response of Retinal Ganglion Cells in Normal and Genetically Modified Mice Species: Mice

Funding Sources: National Institutes of Health (NIH): R01-EY034223 and Non-PHS Funding

For this investigator's first incident of this nature, the IACUC determined that the following finding constituted *serious* noncomplianceⁱ with the federal regulations:

9/28/2022 – Animals were given an expired drugⁱⁱ

During a semi -annual inspection, the laboratory drug logs were reviewed and expired Ketamine was used to make a Ketamine/Xylazine cocktail which was given to five mice for euthanasia. There were no concerns with the effectiveness of the drug cocktail and a secondary method of euthanasia was performed on the animals.

12/13/2022 – Determination at a fully convened IACUC meeting

To protect the welfare of animals and prevent future recurrence, the IACUC required following corrective actions:

- All research personnel are required to complete the following AALAS modules: Guide for the Care and Use of Laboratory Animals and Working with Controlled Substances
- All research personnel are required to complete the interactive course "Top 10 Pitfalls in Animal Research and How to Avoid Them" training.
- 3. All research personnel are required to review the policy "Guidelines for Use of Pharmaceutical and Non Pharmaceutical Grade Drugs Chemical and Other Substances."

This finding of non-compliance does not appear to pose any potential or actual effect on costs related to this PHSsupported research.

¹ PHS Policy IV.F.3.a: "The IACUC, through the Institutional Official, shall promptly provide OLAW with a full explanation of the circumstances and actions taken with respect to: a. any serious or continuing noncompliance with this Policy;"

[&]quot; PHS Policy IV.C.1.b: "Procedures that may cause more than momentary or slight pain or distress to the animals will be performed with appropriate sedation, analgesia, or anesthesia, unless the procedure is justification for scientific reasons in writing by the investigator."

This notification will also be sent to AAALAC International, the National Institutes of Health and the non-PHS funding source according to the terms and conditions of the award.
