Dear Dr. Christian,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your September 27, 2022 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Saint Louis University following up on an initial September 2, 2022 notification by telephone.

According to the information provided, this Office understands that the Saint Louis University Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to failure to adhere to the activities described in the standard operating procedure (SOP) for the care of the animals and procedures described in the approved animal use protocol. The final report states on August 19, 2022, eleven juvenile red-eared slider turtles were found dead under the basking platform located within a housing water tank in a satellite housing facility. On the same day, the principal investigator (PI) notified the IACUC Chair and Attending Veterinarian of the incident.

It was concluded that incident was the result of improper reinstallation of the basking platform following routine husbandry. As a result, the turtles swam under the platform, but were unable to exit to access air. The matter was discussed at an IACUC meeting and the committee approved short-term and long-term corrective actions. The PI has agreed to work with the IACUC to complete the corrective action plan. The action plan included the following:

- The PI was directed to modify the basking platform structure to prevent trapping of turtles. Note:
   This action has been completed.
- The veterinary staff will meet the PI and the PI's staff to discuss the importance of following all husbandry SOPs for the care of the turtles and all procedures described in the PI's approved animal use protocol. This action must be completed by November 15, 2022.

It is noted that this research is not supported by PHS funding. Based on its assessment of this explanation, OLAW understands that the Saint Louis University has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

Potential or actual effect on PHS supported activities: None. Investigation indicated this research was not supported by PHS funds.

#### Incident Description:

- On August 19, 2022, in a satellite housing facility, 11 juvenile red-eared sliders turtles were found dead under the basking platform located within a housing water tank.
- On August 19, 2022, the Principal Investigator emailed the IACUC Chair and Attending Veterinarian to report this incident.

#### Investigation:

- On August 23, 2022, The IACUC Chair and PI discussed the incident by telephone and concluded the incident was due to improper reinstallation of the basking platform following routine husbandry. As a consequence, turtles swam under the platform but were unable to exit to access air.
- On September 2, 2022, the Chairman of the Saint Louis University IACUC contacted OLAW by phone to make an initial report of the incident.
- On September 13, 2022, this incident of noncompliance was discussed at the regularly scheduled IACUC meeting. Short term and long-term corrective actions were approved by the IACUC. The PI was directed to make structural modifications on the basking platform to eliminate the possibility of turtles becoming trapped. The PI and the PI's staff were directed to meet with the Veterinary staff to discuss the importance in following all husbandry SOPs for

- the care of the turtles and all procedures described in the PI's approved animal use protocol.
- On September 26, 2022, the IACUC chairman sent the PI a letter detailing the
  IACUC's conclusion that the incident was noncompliant with activities described
  in the SOP for the care of the turtles and procedures described in the PI's animal
  use protocol. The letter also described the corrective action plan approved by
  the IACUC to ensure future compliance by the PI.
- On September 26, 2022, in a return letter the PI agreed to work with the IACUC and complete the outlined corrective action plan.

#### Corrective Actions taken by the Institution to address the situation:

#### Short term:

- On September 26, 2022, the IACUC chairman sent the PI a formal letter describing the incident, the IACUC's findings, and indicating that a report of this incident was made to OLAW.
- The PI was directed to modify the basking platform structure to prevent trapping of turtles. This has been completed.

#### Long term:

The Veterinary staff will meet with the PI and the PI's staff to discuss the
importance of following all husbandry SOPs for the care of the turtles and all
procedures described in the PI's approved animal use protocol. The meeting of
PI and staff with the Veterinary staff must be completed by November 15, 2022.
