Dear Dr. Connor,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of a December 6, 2022 letter, co-signed by you, reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals within the animal care and use program at the University of Wisconsin – Madison. The letter supplemented the information in the preliminary telephone report on August 31, 2022. According to the information provided, OLAW understands that on July 19, 2022, it was determined that laboratory personnel did not place an intravenous catheter for surgery nor administer intravenous (IV) fluids as detailed in their animal care protocol during surgery on a sheep. On inspection of previous records, a different sheep had also undergone the same orthopedic procedure on February 2, 2022, without the required IV catheter or fluids. In addition, during post-operative observations, an animal care technician did not notify the Research Animal Veterinarian or their supervisor in a timely manner, that a prosthetic device had become unattached from the sheep. Both sheep were unharmed and did not appear uncomfortable or experience any morbidity at any time. The animals were associated with an NIH-supported activity.

Corrective and preventive actions: Retraining of the laboratory personnel was completed by the Research Veterinarian and retraining of the animal care technician was completed by the Research Program Associate Director. The laboratory has been instructed on the importance of adhering to the approved protocol and the laboratory animal technician retrained on the importance of timely veterinarian notification of unanticipated problems.

The consideration of this incident by the University of Wisconsin - Madison was consistent with the philosophy of institutional self-regulation. Similarly, the action taken to prevent recurrence was appropriate. We appreciate being informed of this matter and find no cause for further action by this office.

The University of Wisconsin-Madison, in accordance with Assurance A3368-01 and PHS Policy IV.F.3, is providing this report of an incident.

On 7/19/2022, a laboratory performed an IACUC-approved orthopedic procedure on a sheep but on post-operative veterinary observations, it was determined that laboratory personnel did not place an intravenous catheter for surgery nor administer intravenous (IV) fluids as detailed in their animal care protocol. On inspection of previous records, a different sheep had also undergone the same orthopedic procedure on 02/02/22 without an IV catheter or fluids as approved in the protocol. In addition, during post-operative observations, an animal care technician did not notify the Research Animal Veterinarian or their supervisor in a timely manner, that a prosthetic device had become unattached from the sheep. Both sheep were unharmed and did not appear uncomfortable or experience any morbidity at any time.

Retraining of the laboratory personnel was completed by the Research Veterinarian and retraining of the animal care technician was completed by the Research Program Associate Director. The laboratory has been instructed on the importance of adhering to the approved protocol and the laboratory animal technician retrained on the importance of timely veterinarian notification of unanticipated problems. The animals were associated with an NIH-supported activity. The School of Veterinary Medicine's Institutional Animal Care and Use Committee discussed this incident and the corrective measures at their monthly meeting on 08/09/22 and required no further action.
