The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your August 10, 2022 memo regarding an incident of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the National Institute for Child Health and Human Development. According to the information provided, OLAW understands that on July 12, 2022, the ACUC was notified that a dish of 30 zebrafish fry were discovered deceased in an incubator on July 1, 2022 (they were apparently not fed, nor did they receive water changes). One staff member assigned to the room was not trained to check incubators, and the other trained staff assigned to the room failed to check the incubators.

Corrective and preventive actions:

- 1. All staff with duties in procedure rooms have been re-trained on working with incubators and reminded to check incubators.
- 2. The room log has been updated to add incubator checks to one of the daily checks that must be signed-off on.
- 3. The aquatics facility is in the process of adapting the technical service request procedure. Until this is fully implemented, the facility manager will follow up on all requests to ensure that they are completed.
- 4. The committee recommends that the NICHD zebrafish facility should operate at a consistent and sustainable staffing level.

The actions taken to resolve the issue and prevent recurrence were appropriate and accepted by OLAW. OLAW agrees that appropriate staffing levels are necessary to properly care for research animals and guard their welfare. We find no cause for further action by this office.

Subject: Animal Incident Report: Zebrafish Fry

In accordance with Assurance D16-00602 and PHS Policy IV.F.3., the IC ACUC provides this report of an incident that occurred involving the care and use of animals in biomedical research.

Summary of incident:

On July 12, 2022, the attending veterinarian informed the ACUC chair that a dish of zebrafish fry (spawned 6/29) was requested by the PI via technical service request to be put "on the system" when 5-7 days old (which would have been 7/4-6). But they never were put on the system. Instead, they were discovered deceased on 7/11 (they were apparently not fed, nor did they receive water changes). Thirty fry in total were affected.

NICHD investigation and response:

The ACUC chair informed OACU via email of the incident on July 13, 2022. The investigative team was formed to include the ACUC chair and attending veterinarian.

SOP for the facility require that care staff check all fish once per day. One staff member assigned to the room was not trained to check incubators, and the other trained staff assigned to the room failed to check the incubators. Room logs were found completed but there is nothing in the logbook to check for incubators. So, there were two missed checks: 1. Whoever received the email for the technical service request did not arrange the transfer to the system; 2. The staff that checks the procedure room were either not trained to check the incubators or failed to check the incubators.

The full NICHD ACUC discussed the incident and investigation at their July 20, 2022, meeting. In addition, to the proposed corrective actions below, the committee recommends that the NICHD zebrafish facility should operate at a consistent and sustainable staffing level.

Corrective actions:

- 1. All staff with duties in procedure rooms are trained on working with incubators. All staff have been re-trained and reminded to check incubators.
- 2. The room log has been updated to add incubator checks to one of the daily checks that must be signed-off on.
- 3. The aquatics facility is in the process of adapting the technical service request procedure to a successful, standardized procedure already in use in NICHD rodent facilities. Until this is fully implemented, the facility manager will follow up on all requests to ensure that they are completed.

The IC ACUC feels these actions will prevent the occurrence of a similar incident in the future.
