The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your September 29, 2022 memo regarding an incident of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the National Institute of Neurological Disorders and Stroke. According to the information provided, OLAW understands that two similar incidents regarding animal deaths due to lack of food. On June 6, 2022, the institute was notified of an incident in which a cage of four mice was found with no food in the hopper. Two mice had died, and two mice recovered with supportive care. While this incident was being investigated, another incident was reported in which a cage of three mice was found with no food in the hopper. All three mice had died. It was determined, that in both cases, a new cage was inadvertently set up without food late in the week, and in each case the oversight went undetected until the following Monday.


Caretaker Staff received retraining and staffing issues appear to have stabilized. Investigators were reminded to confirm the completeness of any new cage setups. No additional incidents have occurred.

The conclusions and actions by the NINDS ACUC are reasonable and accepted by OLAW. OLAW agrees that this incident was reportable. It is understood that no additional problems have occurred since the incident. OLAW views instances of lack of basic living requirements such as food, water, and a proper cage environment with great concern and reminds the IRP that, at a minimum, daily animal observation is a requirement of the Guide for the Care and Use of Laboratory Animals. We appreciate being informed of this matter and find no cause for further action by this office.

The incident involved a failure to prepare and monitor two mouse cages containing seven mice in accordance with facility SOPs. The failure contributed to the death of five mice.

The event was first reported to the NIH Office of Animal Care and Use by the NINDS Animal Program Director on June 6, 2022.

Subject: Animal Incident Report

In accordance with Assurance D16-00602 and PHS Policy IV.F.3., the NINDS/NIDCD/NCCIH ACUC provides this report of two similar incidents that occurred involving the care and use of animals in biomedical research.

Summary of the Incidents:

On June 6, 2022, the APD notified me and OACU of an incident in which one cage of four mice was found with no food in the hopper. Two mice had died and two mice recovered with supportive care. This incident was initially reported to the ACUC at a convened meeting on June 9, 2022. Additional information was requested. On July 25, 2022 the APD notified me and OACU of another incident in which one cage of three mice was found with no food in the hopper. All three mice had died.

The Chair met with the Facility Manager and Facility Veterinarian to discuss the incidents. It was determined that in both cases a new cage was inadvertently set up without food late in the week, and in each case the oversight went undetected until the following Monday. In both cases, unforeseeable personnel issues, resulting in reduced staffing, were thought to be a contributing factor.

Both incidents were discussed at a convened ACUC meeting on August 11, 2022. The Committee concluded these were both reportable incidents involving a husbandry failure resulting in the death of five mice in total.

Corrective Actions:

Caretaker Staff received retraining and staffing issues appear to have stabilized. Investigators were reminded to confirm the completeness of any new cage setups. No additional incidents have occurred. The ACUC believes appropriate corrective actions have been taken.
