Licenses are authorize increments of 50 animals on hand at any single point in time during the period of licensure. A licensee must obtain a new license before using any animal beyond those types or numbers of animals authorized under the existing license.

(b) A registrant which has not used, handled, or transported animals for a period of at least 2 years may be placed in an inactive status by making a written request to the USDA Animal Care Office.

(c) A registrant shall notify the USDA Animal Care Office by certified mail of any change in the name, address, or ownership, or other change in operations affecting its status as a research facility, exhibitor, carrier, or intermediate handler, within 10 days after making such change.
