Dear Dr. Gibbens,

Texas A&M University respectfully requests the removal of Site 001, 3302 Gaston Ave, Dallas, TX 75246 from the Registration associated with Certificate Number 74-R-0039 consistent with § 2.30(d)(1):

"A research facility that goes out of business or ceases to function as a research facility, or that changes its method of operation so that it no longer uses, handles, or transports animals, and does not plan to use, handle, or transport animals at any time in the future, may have its registration canceled by making a written request to the Deputy Administrator."

Site 001 no longer uses, handles or transports animals as described in the Animal Welfare Act and Animal Welfare Regulations, nor has plans to use, handle or transport animals in the future.

As the Institutional Official, I am authorized, on behalf of Texas A&M University Health Science Center, to legally commit that the requirements of 9 C.F.R. part 1,2 and 3 will be met under the Animal Welfare Act.
