Dear Dr. Bonnell,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your May 26, 2023 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Pennsylvania. The letter had not been preceded by a preliminary report to OLAW.

According to the information provided and through telecommunication, OLAW understands that the University of Pennsylvania IACUC determined that an instance of noncompliance occurred with respect to failure to follow the institutional euthanasia policy. In late 2022, a research staff member euthanized several groups of mice in the laboratory. While the euthanasia chamber was not overcrowded, the staff member combined mice from different cages each time. In total, 140 mice were euthanized.

The corrective actions consisted of both the Scientist Training Service Group and the PI counseling and retraining all the research staff members in the lab.

Based on the information provided, OLAW understands that the University of Pennsylvania has implemented appropriate measures to address the noncompliance. We appreciate having been informed of these matters and find no cause for further action by this Office.

Dr. Morse,

The University of Pennsylvania would like to report that the euthanasia procedure for a group of mice was inconsistent with the IACUC euthanasia guidelines. Although a researcher used the CO2 euthanasia equipment correctly, home cages of mice were combined for the euthanasia event. A total of one hundred and forty mice were euthanized in this manner. The Principal Investigator and the Office of Animal Welfare Compliance Liaison counseled the research staff members on the issue and arranged for retraining on rodent euthanasia procedures by the Scientist Training Service Group. The grant funding for the study was by 1R01DE031206-01.
