Dear Dr. Bonnell,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your June 20, 2023 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Pennsylvania. According to the information provided, OLAW understands that tail blood collection and tail tissue snips were performed on six rats although these activities had not been described in the approved protocol and were not performed in accordance with institutional guidelines.

The corrective actions consisted of having the animals examined by the veterinarians who found the rats to be in good condition. The Principal Investigator and staff were counseled and the protocol was amended.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

Dr. Morse,

The University of Pennsylvania would like to report a noncompliant event involving six rats. The Principal Investigator (PI) self-reported to IACUC Compliance Subcommittee that his laboratory inadvertently performed two types of procedures that were not on his protocol. The procedures were approved for another species on the protocol, which contributed to the confusion. The procedures were tail blood collection and tail tissue sampling for genotyping. Additionally, the procedures were not performed in a manner consistent with the IACUC guidelines. The veterinary support group examined the rats, and no health issues were noted. The PI and laboratory were counseled on the issue by the Office of Animal Welfare Compliance Liaison team, and an amendment to the protocol was submitted to the IACUC.
