Dear Dr. Bonnell,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your July 26, 2023 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Pennsylvania. This letter had not been preceded by a preliminary report to OLAW.

According to the information provided, this office understands that the University of Pennsylvania Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to conditions that jeopardize the health/well-being of animals resulting in harm/death to animals. The final report states a researcher identified a mouse on study with a probable bite wound on the leg. The individual decided to euthanize the animal, and the mouse was set aside in a cage for euthanasia. However, the researcher forgot about the mouse, and the animal was discovered the following day by an Animal Care Technician. The lab was notified, and the animal was promptly euthanized.

The report states the animal did not receive appropriate attention nor did the animal have food or water available overnight. The IACUC's Compliance Subcommittee was contacted by the researcher regarding the incident. The researcher agreed to change their practice of either euthanizing a mouse immediately when identified or placing food and water in a temporary holding cage. Per telecommunications, it is understood the subcommittee determined the corrective actions to be acceptable.

It is noted that this study is supported by PHS funding. Based on its assessment of this explanation, OLAW understands that the University of Pennsylvania has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

The University of Pennsylvania would like to report a noncompliance issue. A researcher was working with study mice, and he identified a mouse with a probable leg bite wound. The researcher decided to euthanize the mouse. The mouse was set aside in a cage, but the researcher forgot to euthanize the mouse. The mouse was discovered early the following day by an Animal Care Technician. The laboratory was contacted, and the mouse was promptly humanely euthanized. However, the mouse did not receive proper attention nor have food or water available overnight. The researcher contacted the IACUC's Compliance Subcommittee about the event. He agreed to change his practice of either euthanizing a mouse immediately when identified or placing food and water in a temporary holding cage.

The IACUC approved the study, and the grant funding was 2R35GM122475-06.
