Dear Dr. Bonnell,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your July 27, 2023 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Pennsylvania. This letter had not been preceded by a preliminary report to OLAW.

According to the information provided, this office understands that the University of Pennsylvania Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to conditions that jeopardize the health/well-being on animals resulting in harm/death to animals. The final report states two incidents occurred where young trout jumped out of their fish tanks and died. The first incident occurred when the fish tank cover was mistakenly left ajar, and the second incident occurred when two fish jumped over a barrier to get into an area of the tank near the water pump's pipes and then jumped out of the tank.

The Principal Investigator was very responsive, and the laboratory designed new heavier acrylic tank tops. These tops are more secure and provide better tank coverage. Per telecommunications, it is understood the IACUC's Compliance Subcommittee was notified of the event, monitored the correction, and deemed the corrective actions to be appropriate.

It is noted that this study is supported by PHS funding. Based on its assessment of this explanation, OLAW understands that the University of Pennsylvania has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

The University of Pennsylvania would like to report two adverse events involving a total of 4 fish (young trout). There were two incidents where young trout jumped out of their fish tanks and died. One incident occurred when the fish tank cover was accidentally left ajar, and another occurred when two fish jumped over a barrier to get into an area of the tank near the water pump's pipes and then jumped out of the tank. The Principal Investigator was very responsive and addressed this housing safety issue. The laboratory designed new heavier acrylic tank tops, which are more secure and provide better tank coverage. The fish studies are part of the IACUC-approved protocol. The IACUC Compliance Subcommittee was informed about the issue and monitored the correction. The grant funding for the study was by 2-R01-GM-085207-09.
