Dear Dr. Vrana,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your April 21, 2023 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals within the animal care and use program at the Pennsylvania State University – College of Medicine. Your letter supplements the information in the prompt telephone preliminary report made on March 28, 2023. According to the information provided, OLAW understands that on March 23, 2023, it was determined that mice continued to be bred while a protocol was expired and on holding. Laboratory technicians also requested euthanasia of remaining animals, although they had not reached humane endpoint. Additionally, the lab did not follow the standard process for documenting and resolving veterinary observation/clinical care for two mice. Lab personnel removed cage cards indicating observation prematurely, preventing documentation of resolution of the clinical cases. The associated activity is PHS funded.

Corrective and preventive actions:

- The PI and laboratory personnel were reminded that no animal work, including breeding and euthanasia for any reason other than animal welfare or humane endpoint, may be conducted while a protocol is expired, and animals are on holding.
- The IACUC office should update the standard protocol expiration communication to PIs to explicitly clarify that no animal work may be conducted includes breeding and euthanasia for any reason other than animal welfare or humane endpoint.
- The PI and laboratory personnel must follow the process for animals under veterinary observation, including not removing "observation" cage cards until the clinical case has been resolved/animal euthanized (the IACUC-approved SOP should be provided).

The consideration of this matter by the Pennsylvania State University – College of Medicine was consistent with the philosophy of institutional self-regulation. Similarly, reporting the issue to OLAW was appropriate. We appreciate being informed of this matter and find no cause for further action by this office.



Re: Conduct of animal-related activities beyond the expiration date established by the IACUC; Animal Welfare Assurance D16-00024 (A3045-01); PHS funded

Dear Dr. Morse,

The Pennsylvania State University College of Medicine, in accordance with Assurance D16-00024 (A3045-01) and PHS Policy IV.F.3., provides this report of noncompliance that occurred March 23, 2023, in which mice continued to be bred while a protocol was expired and on holding. Laboratory technicians also requested euthanasia of remaining animals, although they had not reached humane endpoint. Additionally, the lab did not follow the standard process for documenting and resolving veterinary observation/clinical care for two mice. Lab personnel removed cage cards indicating observation prematurely, preventing documentation of resolution of the clinical cases. This incident was first reported to you on March 28, 2023 by a voicemail from Dr. Jenelle Izer.

To address the situation, the IACUC recommended the following corrective action plan:

The PI and laboratory personnel were reminded that no animal work, including breeding and euthanasia
for any reason other than animal welfare or humane endpoint, may be conducted while a protocol is
expired and animals are on holding.

This information was provided to the PI upon determining that euthanasia had been requested by laboratory personnel and was reiterated again after IACUC review of the concern, to ensure the PI transfers any remaining animals to an active protocol and/or the expired protocol renewed.

- The IACUC office should update the standard protocol expiration communication to PIs to explicitly clarify that no animal work may be conducted includes breeding and euthanasia for any reason other than animal welfare or humane endpoint.
- The PI and laboratory personnel must follow the process for animals under veterinary observation, including not removing "observation" cage cards until the clinical case has been resolved/animal euthanized (the IACUC-approved SOP should be provided).

The findings of the investigation and actions taken were reviewed at a convened meeting of the IACUC on March 27, 2023. The IACUC recommended to the IO that the incident be reported to OLAW.
