Dear Dr. Saunders,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your letter dated June 16, 2023, reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Drexel University. Your letter supplements the information provided in a preliminary report to this office on May 18th. According to the information provided, OLAW understands that on May 12th, 2023, it was reported that two cages of rats (n=5) appeared frail and thin. The laboratory was immediately notified. All animals were removed from food restriction on May 12th. On May 15th, the PI stated two cages of female rats (n=5) that were on food restriction did not receive care from May 5th-11th, due to a miscommunication between two members of the lab. The reason for the failure to identify that animals were not fed was a range of animal numbers were used on the chart instead of individual numbers. The study is sponsored by NIH.

Corrective and preventive measures: To avoid these miscommunications, all lab members have been asked to communicate animal care requests by email, specifically list all individual animal numbers (and not ranges), and to attach cage cards to their emails. They will also specifically list all individual animal numbers (and not ranges) on the daily food restriction feeding chart that should ensure they fed all the animals. The PI will also be copied on all emails and receive a text message as soon as the animals are fed so she can check to confirm all the animals are fed.

Based on the information provided, OLAW is satisfied that appropriate actions have been taken by Drexel University to investigate this incident, provide corrective measures, and prevent recurrence. OLAW concurs that the incident warranted reporting. We appreciate being informed of this matter and find no cause for further action by this office.

Drexel University, in accordance with Assurance D16-00138 and PHS Policy IV.F.3., provides this report of noncompliance regarding an oversight of care on five rats (*Rattus rattus*). This study is sponsored by NIH. The preliminary report was assigned case number **A3222-1M**.

On May 12^{th} , 2023, it was reported by a ULAR Animal Care Technician that two cages of rats (n=5) appeared frail and thin. The laboratory was immediately notified.

In a self-report submitted by the Principal Investigator (PI) on May 15^{th} , 2023, the PI stated two cages of female rats (n=5) belonging to a protocol that were on food restriction did not receive care from May 5^{th} –11th, 2023 due to a miscommunication between two members of my lab. The PI was away at a conference and lab's primary care giver for these animals was away attending a family emergency out of the country and had requested another lab member to provide the care. These two cages of animals were undergoing behavioral tasks in another room when he physically showed her all the cages in the animal housing room that needed to be fed. The primary caregiver likely forgot to mention that there were two other cages of animals. These two cages of animals were also on a separate rack in the animal housing room and the temporary caretaker did not realize they all belonged to the same protocol and were on food restriction. The lab does maintain the food restriction records and the charts are filled in everyday after feeding. The reason for its failure to identify that animals were not fed was a range of animal numbers were used instead of individual numbers on the chart (eg: Z1-Z16-Z32 while the animals that were missed was Z17-Z21).

As of May 15th, 2023, all animals were removed from food restriction on May 12th and have regained healthy weight. Given the stress the animals have experienced over this period, the PI

confirmed these animals were removed from the behavioral studies and were euthanized on May 17th.

The self-report included a proposed preventative plan. To avoid these miscommunications, all lab members have been asked to communicate animal care requests by email, specifically list all individual animal numbers (and not ranges), and to attach cage cards to their emails. They will also specifically list all individual animal numbers (and not ranges) on the daily food restriction feeding chart that should ensure they fed all the animals. The PI will also be copied on all emails and receive a text message as soon as the animals are fed so she can check to confirm all the animals are fed. She takes personal responsibility to ensure all animals are maintained in good health and these mistakes will not be repeated.

On June 14th, 2023, the IACUC reviewed the self-report and the action plan and voted to accept the plan.

Drexel University is committed to protecting the welfare of animals used in research and appreciates the guidance and assistance provided by OLAW in this regard.
