The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your letter dated October 13, 2023, reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Drexel University. Your letter supplements the information provided in a preliminary report to this office on September 18, 2023. According to the information provided, OLAW understands that four cages of rats, which had surgery on August 26, 2022, were discovered on August 15, 2023. The maximum protocol-approved post-surgery survival timepoint was six months. The rats were in good health and did not show any signs of pain or distress. The one-year survival which the lab never intended to exclude and presumed was approved was not included in the current protocol. The activity was PHS funded.

Corrective action: The PI submitted an amendment to add and justify the one-year post surgery time point. The amendment was approved.

Based on the information provided, OLAW is satisfied that appropriate actions have been taken by Drexel University to investigate this incident and provide a corrective measure. OLAW concurs that the incident warranted reporting. We appreciate being informed of this matter and find no cause for further action by this office.

Drexel University, in accordance with Assurance D16-00138 and PHS Policy IV.F.3., provides this report of noncompliance regarding a protocol deviation involving post-surgery survival timeline. This study is sponsored by NIH. The preliminary report was assigned case number A3222-1P.

Four cages of rats, which had surgery on August 26, 2022, were discovered on August 15, 2023. In reviewing the protocol, the longest post-surgery survival timepoint was six months. These rats discovered were nearing a one-year post-surgery recovery. The rats were in good health and did not show any signs of pain or distress.

The PI indicated that a one-year post-surgery survival was a previously approved time point in their ongoing research which was based on guidance and recommendations from clinical consultants. The one-year survival which the lab never intended to exclude and presumed was approved was not included in the current protocol. To rectify, the PI submitted an amendment to add and justify the one-year post surgery time point.

On September 13, 2023, the IACUC reviewed the amendment to add and justify the one-year post-surgery survival to the study timeline. The amendment to the protocol was approved by the IACUC on September 21, 2023.

Drexel University is committed to protecting the welfare of animals used in research and appreciates the guidance and assistance provided by OLAW in this regard. 
