The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your April 28, 2023 letter responding to my February 13, 2023 request for additional information regarding several instances of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Virginia Polytechnic Institute and State University. According to the information provided, OLAW understands the following:

- Following discussions between the Principal Investigator (PI) and key leadership of the animal
 care and use program, the previously terminated protocol has been resubmitted for Institutional
 Animal Care and Use Committee (IACUC) review. Currently pending documentation consists of
 the verification of personnel training and required wildlife permits.
- 2) The Co-PI stated that the wildlife permitting agency in Brunei did not require notification of the unexpected deaths of bats.
- 3) There were no reported human occupational health and safety incidents.
- 4) The level of post-approval monitoring has been enhanced and now requires weekly "Zoom" meetings with the investigators and IACUC, submission of weekly reports of animal activities, and including these oversight requirements as part of the protocol.

Based on its assessment of this additional information, OLAW has a better understanding of the actions taken by the IACUC to ensure compliance in a foreign field study. OLAW concurs with the actions taken by the IACUC to comply with the PHS Policy and we commend the enhanced post-approval monitoring procedures which were implemented. While OLAW will hereby close this investigation and notify the NSF representative, we request a final confirmation upon completion of the aforementioned action items in #1, including IACUC approval of the protocol. This letter is in response to the OLAW letter received February 13, 2023 in reference to the final report for Animal Welfare Assurance A-3208-01 [OLAW Case 1L]. OLAW requested additional follow-up on several items, please see below. The below represents the results of multiple meetings involving the PI, IACUC, Veterinarians, Department Head, Associate Dean, and staff of the Animal Care and Use Program to ensure the PI has a clear understanding of the expectations of the IACUC if this protocol is to be approved.

- Status of new protocol: The protocol is currently still under review by the IACUC. The IACUC is waiting for final personnel training and wildlife permits.
- Actions required by the permitting agency: Per the PI, the Co-I has confirmed that there was no need to report the deaths of the bats to the wildlife permit agency in Brunei. Hence, he has not done this and no actions where required from the Brunei side.
- 3. Human occupational health and safety incidents: None
- 4. Level of post-approval monitoring: Once animal activity begins the IACUC has required weekly zoom meetings along with the PI or designee will be sending weekly reports of animal activities. These requirements will be instituted for any week animal work is ongoing. This monitoring plan will be part of the approved IACUC protocol.

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your February 3, 2023 letter reporting several instances of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Virginia Polytechnic Institute and State University, following up on an initial telephone report on October 17, 2022. According to the information provided, OLAW understands that on a captive bat study individuals not listed on the protocol were handling the animals, husbandry was provided by students not approved by the Institutional Animal Care and Use Committee (IACUC), personal protective equipment was not being used, adequate veterinary care was unavailable, the species of bat housed had not been approved, humane endpoints were not followed, the euthanasia method was not listed on the protocol and was not an American Veterinary Medical Association approved method, and the Principal Investigator failed to inform the IACUC of any bat deaths. The noncompliance had already occurred when it was anonymously reported to the IACUC and there are no current animal activities ongoing. These activities were performed under NSF awards CBET 2002466 and OISE-1954172.

The corrective actions consisted of the IACUC terminating the protocol due to the magnitude of infractions. The IACUC is meeting with the Animal Care and Use Program staff and the veterinarians to assess the design of this project and how to ensure appropriate oversight prior to potential approval of a new protocol.

Based on its assessment of this explanation, OLAW concurs with the swift action taken by the IACUC to ensure animal welfare and compliance with the PHS Policy. OLAW will inform NSF but will keep this case open until a final decision is made as to whether this protocol is reinstated and until the measures taken to ensure compliance going forward can be evaluated. Please provide an update by April 14, 2023 as to the actions being taken. Include information on any actions required by the permitting agency, whether there were any human occupational health and safety incidents, and the level of post-approval monitoring applied if this study resumes. Thank you for keeping OLAW apprised on this matter.

Final report regarding adverse event at Virginia Tech [Assurance #A-3208-01]

Dear Dr. Morse:

Virginia Tech, in accordance with Assurance A-3208-01 and PHS Policy IV.F.3., provides this report of multiple incidences of noncompliance on an IACUC approved protocol utilizing wild-caught bats. This incident was initially reported to you via phone call on November 17, 2022 after verification of NSF funding.

On October 11, 2022, the IACUC office was anonymously notified of concerns regarding appropriate training of protocol personnel and care of bats. Animal use on the protocol was not ongoing at the time of notification and animal use is not expected to re-initiate until summer 2023. The IACUC discussed the protocol at the December 15, 2022 convened meeting and requested corrective actions from the PI:

- 1. The IACUC issued a serious noncompliance letter and reminded the PI in the future to adhere to the approved protocol. The multiple noncompliance violations addressed in the letter included (1) individuals participated in bat handling who were not approved and listed on the protocol; (2) husbandry of captive bats were performed by Virginia Tech-associated students without IACUC approval or awareness; (3) PPE requirements were not enforced for individuals handling bats; (4) appropriate veterinary care was not available; (5) the majority of bats captured, held, and manipulated were not approved species; (6) humane endpoints were not followed euthanasia by protocol personnel was not described on the protocol and the euthanasia method utilized was not an AVMA-approved method; (7) the PI did not notify the IACUC of bat deaths.
- Due to multiple noncompliance violations and the absence of active animal use on the
 protocol, corrective actions required by the IACUC included (1) requesting the closure of
 the protocol within 48 hours of the receipt of the noncompliance letter, and (2) meeting
 with Animal Care and Use Program staff and Animal Resources and Care Division
 veterinarians to discuss project design, implementation and oversight prior to initiating a
 new protocol.

The funding source for these bats are via the NSF (Federal Award Numbers: CBET 2002466 and OISE-1954172). Per PHS requirement, the PI has been informed that he must cooperate with his grant administrator to determine any funding related actions that must be taken.


