Narrative Supplement for Program Changes for Duke University, Assurance Number D16-00123 (A3195-01)

1. Duke University Animal Welfare Assurance for Domestic Institutions. Section I.B. Triangle Veterinary Referral Hospital, Durham, NC was added as a covered component of the Duke Animal Welfare Assurance for the purposes of the grant. This amendment was approved by the Office of Laboratory Animal Welfare on February 18, 2022.
2. Duke University Animal Welfare Assurance for Domestic Institutions. Section III. B. The qualifications, authority, and percent of time contributed by the veterinarian(s) who will participate in the Program.
Sarah Long is a full-time participant in the Research Triangle Laboratory Animal Medicine residency program. Approximately 50% of her effort is spent serving as a Clinical Veterinarian in DLAR. She is a graduate of North Carolina State University College of Veterinary Medicine. She regularly attends national and regional continuing education provision for maintenance of credential for professional development. She has access to all animals.
3. Duke University Animal Welfare Assurance for Domestic Institutions. Section III. D. 9). Annual reviews are no longer routinely performed for protocols that indicate use of USDA-regulated species. This is in accordance with the USDA/APHIS Final Rule to 9 CFR Parts 2, 3, and 4, [Docket No. APHIS-2019-0001], RIN 0579-AE54.
