
The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your July 3, 2023, update to the series of noncompliance reported previously to this Office at Arizona State University (ASU). According to the information provided, OLAW understands that the IACUC suspended the entire protocol at a June 22, 2023, convened meeting, based on the Principal Investigator's (PI's) failure to fulfil the IACUC requirements to submit a revised protocol with IACUC-imposed restricted animal activities. During a subsequent convened meeting on June 29, 2023, the PI appealed the IACUC's decision to suspend the protocol. However, the IACUC approved a motion to deny the appeal and the Institutional Official was informed of the IACUC's decision to suspend on June 30, 2023. Relevant funding agencies will be notified of the suspension. All animals were transferred to an IACUC-approved protocol pending identification of alternate PIs and/or institutions by the current responsible PI no later than July 29, 2023. Those animals identified for transport to alternate institutions will be held for an additional three months, as needed, in the event planned transfers are delayed. Please be advised that prior approval from the NIH awarding Institute or Center will be required for a change in PI or performance site where PHS-supported animal activities will be performed.

Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate, correct and prevent recurrence of the noncompliance. Your prompt and thorough resolution of this matter is commendable and consistent with the PHS Policy philosophy of monitored self-regulation. We appreciate having been informed of this matter and find no cause for further action by this Office.



The committee previously reported that the PI would be required to submit a revised protocol to be reviewed at the convened June IACUC meeting. On June 22nd, at a convened meeting of the IACUC, the committee was informed that the PI had not fulfilled the requirements conveyed following the May 25th convened meeting. A revised protocol was submitted but it included many restricted activities.

The committee determined at the June 22nd convened meeting that since the May 25th convened meeting, the PI has not demonstrated overall improvement in responding to animal welfare notifications, IACUC guidance, or to program compliance.

The committee voted to suspend the protocol in its entirety. The PI was formally notified following the meeting. The IACUC Institutional Official and PI's academic unit Director were notified of the committee's decision.

ASU's Policies and Procedures Manual (PPM) provides the PI the right to request a hearing for an appeal of the committee's decision. The PI was given until 5:00pm on June 27th to request a hearing, and that request was conveyed to the Chair by the deadline.

A preliminary report was sent to OLAW by email on June 23rd.

An emergency convened meeting of the IACUC was held on June 29th. The committee was provided a copy of the PI's appeal and attendees at the meeting were invited to ask questions. The PI, academic unit Director, and PI's mentoring team representative were present. The committee then approved a motion to deny the appeal. The ASU IACUC IO was informed of the decision on June 30th.

Funding sources will be notified of the actions taken by the committee.

The animals under the protocol were transferred to an approved holding protocol where basic husbandry and maintenance of the strains will be performed while alternate PIs and/or institutions are identified that can use the animals. The PI will have until July 29th to identify alternate PIs and/or institutions. Animals identified for transport to other institutions will be held for an additional three months as needed, should planned transfers be delayed (e.g., heat embargo on shipping, awaiting approval from the recipient institution's veterinarian).
