

HOUSING FACILITIES, GENERAL.

* Room Q6 in Building 2 was in use for animal housing during this inspection. The concrete floor in the room had a large, circular shaped epoxy patch. A depressed area of bare concrete was exposed where the patch had failed and peeled away. Water could pool and collect in the damaged floor area during routine husbandry procedures. Standing water can serve as a reservoir for microbial growth, contribute to excessive humidity levels and inhibit the benefits of cleaning in the animal housing room. Additionally, bacteria and water may degrade unsealed concrete. Facility personnel stated that the floor had been recently repaired. Alternative repair solutions may need to be reviewed.

*A slightly gaping, linear defect was noted in the ceiling of animal housing Room Q14 in Building 2. The defect was visible across almost the entire width of the ceiling and penetrated the dry wall and paint. Although no water stains were seen in the ceiling, the area surrounding the defect appeared moist and prolonged rainfall has recently occurred in the area. Continued deterioration may cause the dry wall ceiling to collapse into the room. Facility personnel indicated the exterior roof will be checked for possible leaks immediately.

All animal housing facilities must be structurally sound and kept in good repair to prevent injury to the animals and facilitate required husbandry procedures. The above identified non-compliances should be repaired or replaced.

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

Room Q3 in Building 2 was housing animals during this inspection. Numerous drain flies were noted on the back wall and in the corner of the walls at the ceiling junction on the left side. An abundance of flies were also noted in the uncovered drain on the left side of the room as well as the wall above the drain.

MISCELLANEOUS.

Three mini pigs suffered leg injuries during husbandry or study activities and were subsequently euthanized. One was during a waterline check where the enclosure door was opened and the animal either jumped or fell out, injuring a leg during the fall. Another was during removal of the animal from its enclosure for an undetermined purpose (cage cleaning/study activity/other), and the animal's hoof was somehow injured in the process; a clear cause of the injury was not able to be determined. A third animal was being dosed via oral gavage and experienced a leg injury while in the restraint sling. In all three of these instances, the injuries were immediately noted, reported to the veterinarian, and euthanasia was performed in a timely manner. The facility has reviewed each incident individually to determine cause, and in each case corrective measures were taken, including re-training of staff and implementing adjustments to water checks and cage removal procedures to prevent recurrence of such injuries. A review of husbandry procedures suggested there is no current or ongoing risks of recurrence. However, these incidents caused serious impacts to animal welfare. Handling of animals must be done as expeditiously and carefully as possible, in a manner that does not cause trauma, overheating, excessive cooling, behavioral stress, physical harm, or unnecessary discomfort. Correct from this time forward.

This inspection was conducted from 20-22 March 2017 with veterinary and compliance staff. An exit interview was conducted on 22 March 2017 with the site director, veterinary and compliance staff.
