Dear Dr. Ressler,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your June 26, 2018 letter reporting a serious deviation from the provisions of the *Guide for the Care and Use of Laboratory Animals* at McLean Hospital, following up on an initial telephone report on June 19, 2018. According to the information provided, OLAW understands that sixteen rats on approved food restriction had not received their allotted food allowance for three consecutive weekends. Miscommunication between the research and husbandry staff as well as a problem with the format of the food log contributed to this failure. The rats lost weight and one was dehydrated.

The immediate action taken upon discovery consisted of treating the sick rat which subsequently died. The corrective actions consisted of maintaining separate food log sheets and keeping them close to the animals. All food restricted animals will now be given unrestricted feed on weekends and the Principal Investigator will feed them on holidays.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy on Humane Care and Use of Laboratory Animals.

Thank you for speaking with me by phone on June 19th, 2018 to file the preliminary report regarding an incident that was discovered at our institution on June 18th, 2018. On June 18, 2018 it was discovered that 6 cages containing 16 Sprague-Dawley rats (2-3 animals per cage) on a daily food-restricted regimen had not received their allotted food allowance over three consecutive weekends (June 2-3, 9-10, 16-17); rats had been food restricted to 85-90% of free-feeding weight to maintain them on a consistent body mass index to accommodate behavioral testing consistent with details described in the IACUC protocol covering the use and care of these research animals. Standard protocol for monitoring animals on food restricted diets includes marking cages with highly-visible, special (green) cage cards and maintaining a food log to ensure that each day, including weekends, animals received their allotted amount of animal chow (17-19 g based on their body weight). During the work week (Mon-Fri) the research laboratory staff (technicians) provided the rats with their allotted food. However, due to a miscommunication between the research laboratory and animal care staff (technicians) - who are attending animals as part of their normal routine husbandry duties over the weekends and had agreed to provide food to foodrestricted animals on study - these 6 cages of rats received no food for 48 hrs over the three consecutive weekends. A major source of this failure had to do with the format of the food log that was being maintained to ensure that food restricted animals were fed their daily allotment; checkboxes that were to be checked by staff indicating that animals were fed were included on a single husbandry sheet documenting husbandry for all animals cages in the vivarium, not just food restricted animals. As there was another group of animals also on a food restricted regimen, the food log had been checked when this second set of animals received food, but not these 6 cages of rats. As a result, animal care staff had believed that all food-restricted animals had been fed.

The failure in the monitoring system and impact of the situation became clear on June 18, 2018 (Monday) when staff observed overall weight loss in this group of rats and one rat presented as sick-looking (thin and dehydrated) and had paraphimosis. The Attending Veterinarian treated the rat with subcutaneous fluids and offered wet food, trail mix and hydrogel in the bottom of the cage. Unfortunately, the animal expired the next day.

The situation was reported by the PI and Attending Veterinarian to the IACUC Chairman on June 18, 2018 and a meeting of all individuals involved was convened on June 20, 2018 to discuss the incident and corrective actions. The immediate and long-term corrective plan, implemented by the PI and animal care staff, now involves the maintenance of separate food log sheets in close proximity to each group of animals maintained on food restriction. Further, so as to completely avoid this situation in the future, animals will be provided with food ad libitum over the weekends and the PI will provide food himself on Holidays

that fall on weekdays. With this corrective plan in place, it is reliably assured that such an incident will never happen again.
