The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your March 26, 2018 letter reporting an adverse event involving rats and a serious deviation from the provisions of the *Guide for the Care and Use of Laboratory Animals* at Brigham and Women's Hospital. According to the information provided, OLAW understands that nine rats died after an experimental chamber malfunctioned. The investigators had not informed the facility managers that the study had started using this equipment so health checks were not performed over the weekend.

The corrective actions consisted of the laboratory stopping use of the chamber, developing a standard operating procedure (SOP) for calibrating and monitoring the chamber, and upgrading the equipment. The SOP was approved by the Institutional Animal Care and Use Committee, the laboratory will follow this SOP, will increase monitoring, and report back to the IACUC. The laboratory will also inform the facility managers when the chambers are in use to ensure that daily health checks are conducted.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy on Humane Care and Use of Laboratory Animals.

Non-Compliance Report: Assurance A4752-01 Brigham and Women's Hospital IACUC

Dear Dr. Morse,

This letter serves as a final report on a resolved issue of non-compliance that has been reviewed at the last meeting of the Brigham and Women's Hospital Institutional Animal Care and Use Committee.

Species: Rats Grant: HHSN271201600772P, 5R01HL131910-02, 1UH2HL123873-01

During veterinary rounds, nine rats were found dead due to a malfunctioning experimental chamber. This had never occurred with similar equipment utilized by the same research team. The Principal Investigator promptly halted further use of this chamber until a plan could be developed to prevent a recurrence. Additionally, the laboratory had not notified the animal facility managers that the experiment had begun in the new equipment resulting in the rats not having received daily health checks as required over the weekend.

The laboratory developed a detailed SOP for calibrating and monitoring the chamber, as well as made some upgrades to the equipment. This new SOP was presented at and approved by the IACUC at the most recent meeting. The laboratory will conduct a new experiment using this SOP, as well as increased monitoring, and report back to the committee with the results of the experiment. The laboratory will also notify the facility managers prior to beginning a new experiment in these chambers to ensure they receive the daily health checks from the facility staff. Barring any further welfare concerns, the IACUC considers this resolved. If any additional concerns arise, the BWH IACUC will promptly notify OLAW.

Thank you for your review of these incidents. Please let us know if any further action is required at this time.
