Dear Ms. Moriarty,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your March 9, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Brigham and Women's Hospital. According to the information provided, OLAW understands that a flow meter for a CO2 euthanasia chamber was not working correctly and the research technician in the laboratory did not know how to use the chamber. Twenty five mice had been euthanized using the malfunctioning equipment.

The corrective actions consisted of stopping further mouse euthanasia until the flow meter was repaired. This was done, the technician was retrained, and signs were posted describing how to adjust flow rates for euthanasia. The Institutional Animal Care and Use Committee (IACUC) verified that the equipment was working correctly, and that the technician was using it properly.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the IACUC to comply with the PHS Policy.

Dear Dr. Morse,

This letter serves as a final report on a resolved issue of non-compliance that has been reviewed by the Brigham and Women's Hospital Institutional Animal Care and Use Committee. During a semi-annual program inspection of a laboratory use area, IACUC inspectors found the flow meter for CO2 was not functioning properly. The research technician from the lab present for the inspection did not know how to properly utilize the equipment. The inspection team asked the lab to discontinue euthanasia of mice with this equipment until it was repaired, and the lab member was retrained on its use. The PI informed the IACUC Administration that approximately 25 mice were euthanized during the period when the flow meter was malfunctioning.

The laboratory replaced the improperly functioning flow meter and posted signage describing how to properly adjust the flow rate for euthanasia. An IACUC Inspector revisited the use area and confirmed the equipment is installed corrected and observed proper use of the equipment by the retrained lab member.

Due to these corrective actions, the IACUC now considers this issue resolved.
