The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your October 11, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Brigham and Women's Hospital. According to the information provided, OLAW understands that five mice died subsequent to a new research fellow miscalculating a drug dose and administering a higher dose than what was described in the protocol. The lab identified and self-reported the incident. It was stated that the animals were assigned to an activity receiving PHS funding.

Preventive and corrective actions included the laboratory amending the protocol to clarify the dosing and also providing retraining to the new member.

The consideration of this matter by Brigham and Women's Hospital was consistent with the philosophy of institutional self-identification and self-regulation. Similarly, the actions taken to correct and resolve the issue were appropriate and would be expected to prevent a recurrence of this incident. We appreciate being informed of this matter and find no cause for further action by this office at this time.

Non-Compliance Report: Assurance *A4752-01* Sponsor: 5R21AI130669-02; 5R01AI138999-02 Brigham and Women's Hospital IACUC

Dear Dr. Morse,

This letter serves as a report on an issue of non-compliance that was reviewed by the Brigham and Women's Hospital Institutional Animal Care and Use Committee. A laboratory identified and self-reported that five mice were found to have unexpectedly died during an experiment. The laboratory investigated the incident and determined that a new research fellow had miscalculated a drug dose and gave the mice a higher dose than what was described in the protocol. The laboratory decided to amend the protocol to clarify the dosing and provided retraining to that laboratory member to ensure that this does not occur again. The BWH IACUC encourages laboratories to self-report any adverse events or unexplained deaths and commended this laboratory for bringing this issue to their attention.
