Dear Ms. Farrell,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 31, 2018 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Massachusetts Eye and Ear. According to the information provided, OLAW understands that two guinea pigs failed to receive the complete required analgesic regimen following surgery. The animals were reportedly not exhibiting signs of pain or distress the day after surgery.

The corrective actions consisted of the Attending Veterinarian (AV) counseling the Principal Investigator on the requirement for following the approved analgesic regimen and maintaining medical records. A Protocol Summary Statement form was developed which lists all procedures and treatments to ensure that all activities have been performed as approved. The form will be signed by the animal users and reviewed by the AV.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

Dear Dr. Morse.

On January 17, 2018 a quorum of the Mass Eye and Ear Institutional Animal Care and Use Committee (IACUC) found, by a unanimous vote, that a laboratory conducted a reportable violation of our Institute's PHS Assurance #D16-00215.

The committee voted unanimously that a PI committed the following violation:

• Failure to administer analgesia: The PI on the project failed to administer to two guinea pigs the approved doses of Meloxicam on both the day following survival surgery and the subsequent day. The animals underwent a craniotomy as well as a nerve bundle (oliocochlear neurons) cut. The surgeries were performed on December 19 & 20, 2017. The animals did not appear to be in pain or distress the day after surgery.

This procedure was conducted on an NIH-funded protocol (grant number: 2R01 DC 001089-23A1).

Upon discovery of the violation, the following steps were taken:

- Dr. Mike Kaplan, the Attending Veterinarian (AV), met with the PI to review post-operative care
 and treatment procedures. During the meeting, the importance of strictly following and
 carefully documenting the IACUC-approved analgesic treatment regimen was emphasized
 regarding animal welfare as well as medical record compliance. The PI was contrite, receptive
 and understanding during the discussion and the AV reported to the Committee that he has
 no doubt that the PI has learned a valuable lesson from the experience.
- A newly developed Protocol Summary Statement for regulated species has been developed to help animal users with the various treatments performed. The Summary Statement, completed by the animal users and reviewed for accuracy by the AV, contains a chart that identifies both surgical and non-surgical procedures and their associated treatments. The completed chart will help to ensure that the appropriate drugs, dosages and treatment frequencies of administration are being used. This chart will be especially useful in protocols describing more than one procedure and/or having multiple animal users. The animal user as well as the PI are required to sign the end of the Protocol Summary Statement.

The Committee reviewed the issue of non-compliance at a convened meeting and voted unanimously that the actions taken after the violation were sufficient.
