Dear Dr. Murray,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your September 28, 2018 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Creighton University. This issue was reported to our office by phone on August 7, 2018. According to the information provided, OLAW understands that on July 23<sup>rd</sup> a three-day treatment of carprofen was prescribed once daily for two microswine with mild lameness. On July 25<sup>th</sup> it was determined that the previous day dose had not been administered. The veterinarian was notified and discontinued treatment in the absence of current signs of lameness. The activity to which the pigs were assigned was funded by the PHS.

Corrective actions included counseling of the responsible individual by the Animal Resource Facility manager. It is understood that you will report this issue to the NIH funding components and to the USDA.

The prompt consideration of this matter by Creighton University was consistent with the philosophy of institutional self-regulation. Similarly, the actions taken to resolve the issue and prevent recurrence were appropriate. We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Morse:

Creighton University is submitting a finalized written report regarding an incident that took place on July 24, 2018. The University's Research Compliance Auditor made the initial report to you via phone on August 7, 2018.

#### Background Information/Animal Welfare Issue:

On July 23, 2018, 2 microswine were observed with mild lameness. As a result, a 3 day treatment of carprofen was prescribed once daily (SID) through July 25, 2018. On the morning of July 25, 2018 a member of the Animal Resource Facility (ARF) discovered the previous' day dose of carprofen was present in the medication bin and neither animal received their second dose of carprofen on July 24, 2018. The Attending Veterinarian (AV) was immediately notified of this oversight; however, given that neither animal displayed signs of lameness the AV decided to discontinue the treatment.

#### **Corrective Action Plan Taken:**

The following corrective action plan was created and submitted by the Animal Resource Facility Manager to prevent reoccurrence of this noncompliance:

 The ARF manager met with personnel responsible for this oversight and reviewed the importance of the daily process of checking the medication bin and door sheets on each animal room for any special instructions including medications.

- Additionally, the Association for Assessment and Accreditation of Laboratory Animal Care International (AAALAC) will be informed of this noncompliance.


