The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your September 27, 2018 report of an incident of noncompliance with the PHS Policy on the Humane Care and Use of Laboratory Animals at the University of Virginia (UVA Compliance Case #: 2018-M). Your final report supplements the preliminary report sent via email on September 14, 2018. According to the information provided it is understood that expired anesthetic had been used to induce deep anesthesia prior to rapid euthanasia in mice. Depth of anesthesia had been verified via toe pinch prior to euthanasia. It was stated that the animals were assigned to a PHS-funded activity.

The corrective actions consisted of the PI providing the IACUC with a corrective action plan. This consisted of the PI counseling his laboratory staff regarding the concerns. The PI also improved drug usage and expiration documentation and created an automatic weekly email reminder for all lab members and then again the day prior to the expiration of substances administered to animals. The PI reviewed the new procedures with laboratory staff.

OLAW believes that the corrective and preventive measures put in place by the University of Virginia are consistent with the provisions of the PHS Policy on Humane Care and Use of Laboratory Animals. We appreciate being informed of this matter and find no cause for further action by this office.

UNIVERSITY OF VIRGINIA ANIMAL WELFARE COMPLIANCE REPORT

PHS Assurance # A3245-01

A preliminary email notification was sent to Dr. Brent Morse of OLAW by Angela Gamble, Director of the Office of Animal Welfare. It was understood that a full report would follow IACUC investigation. This document is a summary of the incident, actions taken, and final resolution.

UVA Compliance Case #: 2018-M

Nature of Incident(s):	Use of expired anesthesia (mice)
Summary of Incident:	During a follow-up visit, the Office of Animal Welfare (OAW) Compliance Associate found an expired bottle of anesthetic that had been used beyond the expiration date. A high dose of the anesthetic was used to induce deep anesthesia prior to rapid euthanasia. The depth of anesthesia had been verified prior to euthanasia via toe pinch. The expired anesthetic was used within 35 days of the listed expiration date.
Action taken by IACUC:	The OAW Director contacted the PI to discuss the finding and requested a corrective action plan to address the issue. The IACUC discussed the incident at the next convened monthly meeting and reviewed the corrective action plan provided by the PI. The IACUC determined that the incident was a significant deficiency due to the potential impact on animal welfare.
Action taken by PI:	The PI indicated that the laboratory had two bottles of anesthetic, and from his investigation, he determined that the laboratory staff inadvertently used the bottle of anesthetic that would have expired in 2019 first instead of the bottle expiring sooner in 2018. He acknowledged that regardless, the expired substance should not have been used, and he reviewed the concerns immediately with his laboratory staff. The PI submitted a corrective action plan for improved oversight which included: discarding the expired material; creating an inventory log sheet to include expiration dates; placing the log sheet in the drug storage location; placing an additional notification of expiration dates on the outside of the drug storage location; and creating an automatic email reminder that will be sent to all members of the laboratory once a week and then again one day prior to the expiration substances administered to animals. The PI reviewed the new procedures including the log sheet and reminded the staff to pay careful attention to expiration dates at the most recent laboratory meeting.

Action taken by IACUC:	The IACUC felt that the PI responded appropriately and no further action was deemed necessary.
Decision/Resolution:	The IACUC accepted the corrective action plan as submitted by the PI and considered the incident resolved.
