Dear Dr. Ewalt,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your October 1, 2018 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Princeton University. According to the information provided, OLAW understands that a transgenic mouse with malocclusion was found dead on June 14, 2018 because the treatment plan for the animal was not communicated to the newly assigned animal care technician on July 11, 2018. The animal activity in question was supported by PHS funds.

The corrective actions consisted of retraining all animal care technicians on procedures for treating malocclusion, requiring that teeth clipping be performed solely by veterinary technicians who will also be responsible for documenting treatment and frequency on a red sick card and revising the relevant Standard Operating Procedure to include Principal Investigator notification and sign-off of malocclusion cases.

Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate, correct and prevent recurrence of the noncompliance. We appreciate having been informed about this matter and find no cause for further action by this Office.

Re: Report of Non-Compliance Princeton University/Assurance No. A3434

Dear Dr. Gopee:

Princeton University provides this report regarding a non-compliance and animal welfare incident involving PHS-funded research that was presented to the IACUC at a fully convened meeting on July 26, 2018.

A researcher requested that a transgenic mouse be treated as necessary by Laboratory Animal Resources (LAR) for malocclusion starting on April 25, 2018. The mouse was placed on a treatment plan appropriate for malocclusion to be performed by an animal care technician (ACT). On June 14, 2018 the mouse was found dead. Upon further investigation by an LAR veterinarian, it was noted that the husbandry duties were taken over by a different ACT during the week of June 11, 2018. There was a lack of communication between ACT during the transfer of responsibilities and the new ACT was unaware of the treatment needed on the mouse.

Corrective actions consisted of re-training all ACT and veterinary technicians on the process for malocclusion treatment. This occurred on July 5, 2018. In addition, the following new measures have been put into place to prevent this from happening in the future:

- Clipping of teeth as a treatment for malocclusion will only be performed by veterinary technicians.
- Documentation of treatment and frequency will be tracked using a red sick card by the veterinary technician responsible for performing the treatment.
- LAR Special Services SOP has been modified to include a sign-off and PI notification of these cases. The IACUC reviewed the revised SOP at the September 20, 2018 IACUC meeting. The revised SOP was reviewed with LAR staff on September 27, 2018.

Additionally, re-training has been completed with the ACT regarding the importance of checking every cage and cage card to ensure that important treatments are not overlooked.
