Re: Final Report on USDA Finding for D16-00136

Dr. Morse,

On January 16, 2018, our animal care facilities were inspected by a Veterinary Medical Officer (VMO) from the United States Department of Agriculture's (USDA) Animal Plant Health Inspection Service (APHIS). The inspector had found two chinchillas in separate cages in need of medical attention and contacted the Attending Veterinarian. One animal had discharge from the left eye and the second animal showed evidence of wounds from its cage mates. Medical attention was immediately provided and the wounded animal was transferred to single housing to continue treatment. The VMO provided an inspection report which indicated a direct finding for Attending Veterinarian and Adequate Veterinary Care.

The two chinchillas had arrived at the facility 4 days prior to the inspection. The animals were transported in individual cages. When they arrived, the animals were transferred to social housing with three animals per cage. Animal care staff had performed daily cage checks but it is clear that the wounds to the second animal were missed.

Corrective Action

The veterinary team immediately provided medical assessments and treatments as necessary. The clinical veterinarian and veterinary technician provided hands-on refresher training to all vivarium staff to ensure that morning health checks are thorough so that any future illnesses or injuries are detected promptly.

Review by the IACUC

The IACUC reviewed the information at a convened meeting on January 25, 2018. The IACUC was satisfied that the actions taken are appropriate. The IACUC requested a report of training progress at the next convened meeting on February 22, 2018.

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE.

***The facility did not use appropriate means to prevent, control, diagnose, and treat diseases and injuries of two chinchillas with medical issues.

An 18 month old male chinchilla, with no ear ID in cage 24 housed with 2 other chinchillas, was squinting his left eye. There was a clear dried discharge/substance around the left eye. Additionally, under the chin, there was a hairless area that was approximately 1 centimeter in diameter. The visible skin was pink/red in color.

Cage 45 had a large amount of hair debris in it. When examining the three chinchilla's house therein, one chinchilla appeared to be quiet in demeanor and unthrifty while sitting on top of its plastic shelter. That 18 month old, male, chinchilla, with no ear ID, had a large area of hairloss on his back. The hairless area, approximately 12 cm in length and 2-3 cm in width, was along his entire back. The skin beneath the outer edges of the hairless area was pink. Towards the middle of the hairless area, the skin was dark red in color and inflamed. In the center of the red skin, the skin was dry and scabs had formed. The right ear had damage to the tip and two puncture wounds in the center of the ear. There was dry blood around the base of the left ear, right ear, and at the base of the nose. This chinchilla was immediately placed in a separate cage and the attending veterinarian was called.

The facility received these chinchillas 5 days ago. They were transported individually, and upon arrival they were group housed three to a cage by the facility. Animals housed in the same primary enclosure must be compatible and should not be housed with other animals that interfere with their health or cause them discomfort. Facility staff informed the VMO that these animals' conditions had not been noticed by facility staff. The facility was unable to provide any records indicating that these particular conditions had been treated medically by the facility.

Daily observation of all animals is critical to ensuring that conditions that can adversely affect health and well-being are recognized in a timely manner. Additionally, when observed, problems relating to animal health or behavior must be conveyed to the attending veterinarian so that appropriate methods can be employed to ensure adequate
