SUBJECT: 11-FEB-2020 USDA-APHIS Routine Inspection

On behalf of CHLA and the Saban Research Institute, I am offering this response to two (2) citations presented in a February 18, 2020 inspection report provided by a USDA Veterinary Medical Officer following a routine inspection on February 11, 2020.

1) The report indicates that the facility prepared reports of its evaluations conducted in 2019 September and October but did not submit the reports to the Institutional Official in time to ensure the IO receives evaluations every 6 months. Correction: The evaluations was provided to the IO and future evaluations will be submitted on time to the IO.

2) The report indicates that a significant deficiency noted on the 2019 September IACUC facility review was not corrected by the date scheduled. This missed schedule date for a significant deficiency was not reported to APHIS. On the day of the facility inspection, 7 mice were housed in a room in which IACUC members detected helicopter fumes at the same time as a hospital emergency Medevac helicopter could be heard overhead. Prior to correction, the presence of fumes was brief and infrequent, as it occurs only if a helicopter is diverted from its usual flight path due to a multi-case emergency. CHLA takes the welfare of our patients and our animals very seriously.



Following the report of the deficiency, the hospital spent considerable resources on fume-proofing the room in which the inspection occurred. The deficiency was corrected 1 day after the schedule due date. Correction: the issue was resolved, and the missed schedule date is now reported.

Any failure to adhere to the plan and schedule that results in a significant deficiency remaining uncorrected shall be reported in writing within 15 business days by the IACUC, through the Institutional Official, to APHIS and any Federal agency funding that activity.
