Review Office, Office of Research Protections, U.S. Army Medical Research and Materiel Command, conducted a site visit to the University of Missouri on March 28, 2019 to evaluate the animal care and use program and the animal care facilities. Participating individuals and results of the site visit are outlined in the enclosed checklist. Suggestions for improvement are offered in the absence of regulatory or guideline standards. These "best practices" are methods the staff observed to work well within other programs/facilities and are offered for the institute's consideration.
This AAALAC International-Accredited Animal Care and Use Program is compliant with federal Animal Welfare Regulations and the recommendations of the Guide for the Care and Use of Laboratory Animals (Institute for Laboratory Animal Research). The staff were professional and knowledgeable. The strong collegial culture at the institute was impressive.
The Animal Care and Use Review Office recommends continued funding of the supported animal research to appropriate Department of Defense agencies.
