The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your November 22, 2019 letter reporting an incident of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Mississippi State University. According to the information provided, OLAW understands that an investigator deviated from his protocol by not using an anesthetic regimen that was approved in the protocol. The letter states the protocol describes isoflurane gas will be used to anesthetize mice for oral inoculation and mice will be exposed to isoflurane gas before intravenous injection. However, it was reported that no anesthetic was being used before procedures, which resulted in an incidence of noncompliance.

The corrective action taken was to amend the protocol to include the option of not using an anesthetic regimen. The PI has accepted responsibility for his actions and the IACUC reviewed and accepted the corrective action plan at the IACUC meeting on November 19, 2019. OLAW assumes that the mice that underwent procedures without anesthesia did not experience undue pain/distress and therefore, the amendment to the protocol is appropriate.

Based on its assessment of this explanation, OLAW understands that Mississippi State University has implemented measures to correct and prevent recurrence of this incident. OLAW concurs with the actions taken by MSU Animal Care and Use Committee to comply with the PHS Policy.

We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Wolff:

Mississippi State University, in accordance with Assurance A3160-01 and PHS Policy IV.F.3., provides this report of noncompliance regarding an Investigator who deviated from his protocol by using a different anesthetic regimen than what he stated in his protocol (18-508). Specifically, the protocol stated that his anesthetic regimen would be "For oral inoculation, mice will be anesthetized by isoflurane gas (1 liter/min)." and 'For intravenous injection, mice will be exposed to isoflurane before injection process." However, it was reported that no anesthetic was being used before the procedures, which resulted in a failure to adhere to an IACUC - approved protocol.
