Dear Dr. Summers,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 26, 2018 letter reporting a serious deviation from the provisions of the *Guide for the Care and Use of Laboratory Animals* at the University of Mississippi Medical Center. According to the information provided, OLAW understands that 125 mice and rats died after the heating, ventilation, and air conditioning (HVAC) system malfunctioned and caused extremely high temperatures in the vivarium. The monitoring system also failed and did not sound the alarm to alert staff about the problem. Extremely cold external temperature contributed to the failure of the system.

The immediate action taken upon discovery early the next day consisted of increasing ventilation in the animal room and moving animals to unaffected areas. The HVAC system was repaired, veterinary care was provided to the surviving animals, and investigators were notified. The maintenance staff is determining the exact cause of the failure in order to implement preventive actions.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy on Humane Care and Use of Laboratory Animals.

Dear Dr. Wolff:

The University of Mississippi Medical Center (UMMC), in accordance with Assurance D16-00174 (A3275-01) and PHS Policy IV.F.3., provides this report of a serious deviation from the provisions of the Guide which were related to a mechanical system malfunction involving the HVAC. Approximately 125 mice and rats were affected by this problem and died during the event.

On the evening January 16, 2018, extremely unusual cold temperatures (about 10F) were occurring in Jackson, Mississippi. One environment of the Center for Comparative Research, (CCR) (the vivarium) has its HVAC system on the rooftop, exposed to the elements. During the late evening hours, the system experienced a malfunction which resulted in extremely high temperatures within the animal environment. Temperatures exceeded 90F in several animal housing rooms. Concurrently, the electronic, centrally-administered HVAC monitoring system malfunctioned and did not notify or alarm/alert of the heating problem. Research staff and animal care members reported for work early on the morning of January 17, 2018 to discover the very hot conditions and emergency calls were initiated.

Immediately, increased ventilation was begun and animals were relocated to non-affected areas within the CCR. Maintenance personnel were immediately dispatched and corrective actions were taken. Veterinary care was similarly provided to these affected animals, including improving ventilation and providing a recovery gel diet supplement. Further, all investigators with animals in this environment were notified of the situation and were aware of the issues. In sum, about 125 mice and rats died as a result of increased temperature in the facility.

The Institution is working closely with our maintenance and mechanical division to understand why this situation occurred and to prevent any future recurrence. Engineers have noted that the extreme cold conditions played a prime role in this event and corrective measures are being pursued.
