Explanatory note for 5 cattle within category E of 2017 annual report of research facility:

For this study, cattle were infected with *Theileria parva*, the cause of East Coast Fever. *Theileria parva* causes an inflammatory infectious disease, and our experimental design includes options to administer anti-inflammatory drugs (e.g., banamine) to animals that develop fever and other signs of inflammation. The five cattle identified as Column E did not receive analgesics within the prescribed timeframe and may have experienced fever for a longer period of time than planned. Therefore, we are reporting them in Column E.
